Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Maheshwar Naik, SGT, MPPS Kashagudem, Wardhannapet Mandal regarding denial of promotion.

Shri Maheshwar Naik, SGT, MPPS Kashagudem, Wardhannapet Mandal of Warangal District vide representation dated 22.6.2024 has represented that in the promotions of English language teachers, the ST posts are filled by the General category teachers. Hence, do the justice.

- 2. NCST vide notice dated 27.2.2025 has referred the matter to Commissioner & Director, School Education, Hyderabad for furnishing the facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, the Hon'ble Member (JH) has decided to discuss the issue with the concerned authority and petitioner on 8.4.2025. Accordingly, a sitting notice issued on 02.4.2025 to Commissioner & Director, School Education, Hyderabad and petitioner.
- 3. The Commissioner & Director, School Education, Hyderabad vide letter no. 310/Ser-III-I/2025 dated 7.4.2025 has furnished the facts and informed that due to other official programmes unable to attend the sitting and deputed District Educational Officer, Warangal to attend the sitting. The petitioner joined via Phone Call.
- 4. The petitioner stated that during the Teachers Promotions 2024, (11) School Assistant (English) Posts were notified for promotions in the district, out of which (10) posts were filed as per the merit cum Roaster basis and (01) post of Roaster Point (06) VH (W) is kept in backlog, due to non-availability of eligible candidate and alleged that SGTs under Scheduled Tribe category are ignored in promotions.
- After reorganization of Districts promotion of Teachers was taken up for the first time during June 2024. Since the Districts are reorganized, the new District have started the rosters from Point No.0I on wards, as per rule 22 of Telangana State and Subordinate Service Rules. Totally (11) promotions have been given in Warangal District taking the roster from Point No.0I. Out of the 11 Points, the roster point no.08 is meant for ST (Women). [n accordance with the rules the roster point No. (08) was filled with one Smt.M.Pandari Bai, SGT, who was in general seniority list (30) and who belongs to ST category was promoted without deviating the rules. Out of the 136 sanctioned posts, 13 posts are to be earmarked for ST candidates as percentage of Rule of reservation for STs in SA (English) post. During promotion for the post of SA (English) in 2024 there were no backlog vacancies for STs.Further, it is submitted that, total (13) SA (English) Posts worked out to maintain adequacy in promotions as per percentage of Rule of Reservation to STs. Out of which, 08 SA(English) who belong to STs were already working during the promotions held in 2024. Hence,01 post was earmarked and filled against Roster Point 08 with ST (W) in Cycle-I after reorganization of district in Telangana. Thus, total 09 STs are working as on today after according the promotions in 2024, and remaining 04 posts under Rule of Reservation in promotion to the STs will be filled in the subsequent roster points 15,25,33 and 42,in the Cycle as and when the vacancies are arise, in the ensuing promotion counseling.
- After discussion, the following recommendations were made and action taken report may be furnished to NCST within 30 days from receipt of the minutes.

a. It appears that the justification submitted by the authorities is appropriate. However, The DEO may facilitate in explaining the issue to the petitioner.

b. If the grievance still prevail, the Director, School Education may attend to the next scheduled date of hearing.
