Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Hyderabad in the case of Smt. Madapachi Nagamani, D/o Kumuram Mothiram, R/o Ramjiguda village regarding non provision of employment by SCCL.

**Date of the Sitting: 24/05/2025, 02:30PM**  
**Participants in the Sitting: As per Annexure**

1. The petitioner, Smt. Madapachi Nagamani, D/o Kumuram Mothiram, R/o Ramjiguda village, vide her petition dated 17.01.2025 has stated that her family was displaced due to the Khairiguda open cast mining project of SCCL in 2010 and was identified in the socio-economic survey of New Bordham village at S.No. 40. She stated that her family availed all R&R benefits under G.O.Ms.No. 68 dated 08.04.2005 and was also assured employment under G.O.Ms.No. 34 dated 28.04.2010 as per the SCCL Board's decision dated 26.07.2019. However, due to the omission of her name in the socio-economic survey, her candidature was rejected despite submission of all supporting documents. She further submitted that the Project Administrator & Revenue Divisional Officer, Asifabad, after verifying her documents, recommended her case to the General Manager, SCCL, Bellampalli, on 30.06.2021 for employment under G.O.Ms.No. 34. She cited the judgment in Writ Appeal No. 1297 of 2018 and requested the Commission to direct SCCL authorities to provide her employment in accordance with the said G.O. and official recommendation.
2. NCST vide notice dated 29.04.2025 sought facts and comments from the CMD, Singareni Collieries Company Ltd. (SCCL) within 15 days.
3. No reply has been received. The Commission decided to discuss the issue with the authority and the petitioner on 24.05.2025. Hence a sitting notice was sent on 19.05.2025.
4. In the sitting, the petitioner was present.
5. The petitioner informed that project administrator & Revenue Divisional Officer, Asifabad recommended General Manager, Singareni Collieries Company Ltd, Bellampalli area to provide job to me as per G.O.M.S NO 34 Dt: 28.04.2010. But till the day no action was taken by Singareni authorities and not provided employment to her. The relevant documents are also produced.
6. After hearing to the petitioner, the Commission recommends the following and action taken report to be submitted within 30 days.
  - a. It is noticed that an inordinate delay has happened in providing employment despite the Division bench of Hon'ble High court held that Project Administrator and Joint Collector are in operation and there is no challenge to these proceedings by anyone, including the appellants. It appears to be a case of negligence by the authorities towards providing employment to the poor vulnerable adivasi woman.
  - b. The petitioner may immediately be provided employment as per the provisions.
