Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi in the case of Shri Vaditya Rahul, PhD student at EFLU Hyderabad and resident of Gairanthanda village regarding lack of basic infrastructure in his village (Gairanthanda).

Date of the Sitting: 08/05/2025, 12:20 (Noon) Participants in the Sitting: As per Annexure

Shri Vaditya Rahul, PhD student at EFLU Hyderabad and resident of Gairanthanda village, vide his petition dated December 14, 2024, has requested the Commission's intervention regarding the lack of basic infrastructure in his village, which is predominantly inhabited by Scheduled Tribe members. He has highlighted the absence of proper roads and medical facilities, especially problematic during the rainy season when the village becomes isolated, affecting access to healthcare and education. He has requested the NCST to take up the matter with concerned authorities and ensure the construction of roads, establishment of a primary health center, and deployment of emergency medical units to address the urgent needs of the residents.

- 2. NCST vide notice dated 31.12.2024 sought facts and comments from the Collector and DM, Sangareddy within 30 days from receipt of the Notice. No reply was received by the Commission. The Commission decided to discuss the issue with the authority and the petitioner on 08.05.2025. Hence a sitting notice was sent on 23.04.2025.
- 3. The Collector & DM, Sangareddy District vide letter(s) no. C2/NCST/69/2025 dated 6.5.2025 has sought exemption and furnished the point wise facts/ comments as raised by the petitioner. In the letter, it has been informed that soon after the response to the tender and fixing up the agency, the work of construction of High Level Bridge will be taken up as early as possible.
- 4. In the sitting, the petitioner was present. But the no one was present on behalf of Collector & DM, Sangareddy District.
- 5. The petititioner informed that though significant number of ST Families are living in the said thanda, there is no approach road and the people have to cross the streams to reach their village and many untoward incidences of electric shocks etc have happened and as there is no way for the ambulance to reach, the children and women are facing difficulties especially in the rainy season.
- 6. After discussion with the petitioner and information furnished by the Collector & DM, Sangareddy District, it is decided that the commission may schedule a visit to the said village shortly and the following recommendations were made and action taken thereon may be submit to NCST within 30 days from receipt of the minutes.
- a. The detailed report may be submitted on the profile of the thanda and action taken so far to redress their grievance especially in view of the upcoming rainy season.
 b. The progress of the tender process for the execution of the work may be submitted to NCST so as to know the expected date of completion.
