Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi in the case of Korsa Shanthi and Korsa Abraham Donald, residents of Dammapeta Village, Badradri, Kothagudem District regarding property encroachment and harassment.

**Date of the Sitting: 07/05/2025, 5:45 PM**

Korsa Shanthi and Korsa Abraham Donald, residents of Dammapeta Village, Badradri, Kothagudem District, vide petition dated 16.06.2022 have sought redressal for property encroachment and harassment by Pasumarthi Mukteshwar Rao, Smt. Pasumarthi Dhanalakshmi, Pasumarthi Raghuvulu, and their associates. The petitioners claim to be the lawful owners of agricultural land (Ac. 5.00 guntas) in Survey No. 273/21, which was gifted to petitioner No. 1 by her mother, Smt. Korsa Padma Padmavathi, after the death of her father, Late KorsaRajulu. They allege that Pasumarthi Mukteshwar Rao, Smt. Pasumarthi Dhanalakshmi, and Pasumarthi Raghuvulu, along with their associates, have been trying to illegally acquire their property through fabricated documents. Despite clarifications that the land in question belongs to the petitioners, these individuals have continued to encroach upon it, supported by anti-social elements like Gavara Dhanraj, Aakiveeti Venkatasubba Rao, Dara Yogender, Yarlagadda Bhaskar Rao, Tiruveedula James, MadakamJayamma, and Kursam Diva Prasad. Police officers Jalakam Praveen Kumar and Abbaiah, formerly with the Dammapeta Police Station allegedly harassed them and failed to register appropriate FIRs after the petitioners were attacked by the land grabbers' associates. Hence, the petitioner requested for the justice.

2. NCST vide notice dated 17.10.2022 sought facts and comments from the SP, Distt. Bhadradi Kothagudem within 15 days from receipt of the Notice. The Superintendent of Police, BhadradiKothagudem District, vide letter no. 94/C3/DCRB-BKGM/2022 dated 29.01.2023, has informed that representation made by KorsaShanthi and Korsa Abraham Donald regarding a land dispute and alleged illegal activities. The petitioners have accused several individuals, including former police officers, of fabricating documents and attempting to illegally seize their property. They also alleged that these individuals, with the help of the former police officers, had attacked them, and the police had not taken proper action when the petitioners sought help. The enquiry, however, revealed that the issue is a civil dispute over land and not related to police misconduct. It was also found that Korsa Abraham Donald has a criminal record with multiple cases against him. The police have maintained a rowdy sheet on him and are continuing surveillance. Based on the findings, the Superintendent of Police stated that no further action is required regarding the petitioner's allegations against the former police officers. This letter was forwarded to the petitioner on 21.04.2023 by NCST. The petitioner submitted the rejoinder and requested for sitting.

3. Hence, NCST decided to discuss the issue with the authority and the petitioner on 07.05.2025. Accordingly, a sitting notice was sent on 22.04.2025.

4. In the sitting SDPO, Palvanha and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The SDPO, Palvanha has also reiterated the facts submitted by the SP Office, Bhadradi Kothagudem vide letter dated 29.1.2023.

5. After discussion with the SDPO, Palvanha and petitioner, the following recommendations were made and action taken there on may be submit to NCST within 30 days from receipt of the Minutes.

- a. As the issue relates to a Civil dispute relating to land the Police Department is exempted from the respondents.
- b. The District Collector, Bhadradi Kothagudem may submit an updated detailed factual report duly mentioning if there the matter is sub-judice.


