

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri S Naresh And Others of villages of Chokla Thanda, Kokya Thanda and Peerya Thanda of Yadadri Bhuvanagiri District (Telangana) regarding their habitations being submerged by the Baswapuram Reservoir.

Date of the Sitting: 07/05/2025, 11:45 AM

Shri S Naresh and Others of villages of ChoklaThanda, KokyaThanda and Peerya Thanda of Yadadri Bhuvanagiri District, Telangana vide representation dated 29.11.2024 has alleged that their habitations are being submerged by the Baswapuram Reservoir and they have been requesting compensation for the past 16 years. A total of 240 acres of Land of Chokla Thanda has already been submerged in the reservoir. It is further requested to render justice by the rehabilitation measures and compensation at the earliest.


2. NCST vide notice dated 05.12.2024 sought facts and comments from the District Collector and Magistrate, Yadadri Bhuvanagiri within 30 days from receipt of the Notice.

3. The District Collector & Magistrate, Yadadri Bhuvanagiri vide letter no. G/2715/2022 dated 28.03.2025 has informed that the Revenue Divisional Officer, Bhongir submitted a report stating that the Executive Engineer, Kaleshwaram Project had requisitioned land for the formation of Nrusimha Sagar (Baswapur Reservoir). Upon receipt, the District Collector authorized the Revenue Divisional Officer to process land acquisition under the RFCT in LA RR Act, 2013 and a Preliminary Notification under Section 11(1) was published on 12.03.2025 covering 142 houses, 43 open plots and 10 other constructions. It was noted that Sri S. Naresh's property was notified under SI.No.133 with an extent of 310 sq. yards. The land for relocation of displaced families is under identification and plots along with the R&R package will be allotted to eligible Project Displaced Families as per the Act. NCST has shared the report to the petitioner and upon the request of the petitioner, NCST decided to discuss the issue with the authority and the petitioner on 05.05.2025. Accordingly, a Sitting Notice was sent on 25.04.2025.

4. In the sitting, the District Collector and Magistrate, Yadadri Bhuvanagiri and petitioners were present. The petitioners reiterated their submission and requested for justice at the earliest. They have also provided the list of the displaced families of the villages (which is in Telugu Language) in the sitting (Annexure 1) which was given to District Collector & Magistrate for further action. The District Collector and Magistrate has reiterated their earlier submission and stated that the matter is under active consideration for providing compensation to PDF (Project Displaced Families).

5. After discussion with the District Collector & Magistrate and petitioners, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the minutes.

- The claim of 3 left over families uncovered (i.e, Dharawath Roujya, Azmeera Sandeep and Dharawath Sunder) may be reexamined by the appropriate authorities.
- As informed by the District Collector, the petitioners may approach land Tribunal as they have not raised the claims and objections within the permissible period of 60 days.
- The District Administration, Yadadri Bhuvanagiri District is advised to include the representatives of these villages in the Committee which will identify the beneficiaries for the Project Displaced Families.
- The District Administration may expedite for the speedy settlement of the R&R Package as the petitioners lose year after year in case of delay as there will be discrepancy between the registered value and the actual land rates.
- The action may be initiated on priority basis by the concerned department for providing the compensation to PDF (Project Displaced Families), as they are suffering from economic and social issues.
- The youth of project affected families and female members may be provided with necessary livelihood assistance in outsourcing or contract basis may be planned in the neighboring institutions like AIIMS, Bibinagar.
