Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sri Chavalam Venkanna Dora of Ravilanka village of Devipatnam- Mandal of Alluri Sita Rama Raju District regarding violation of Land Transfer Regulations in Schedule V areas of the District.

**Date of the Sitting: 09/04/2025, 02:00PM**

Sri Chavalam Venkanna Dora, Ravilanka village, Devipatnam- Mandal of Alluri Sita Rama Raju - District (Andhra Pradesh) vide his representation dated 11.11.2024 has alleged about violation of Land Transfer Regulations in Schedule V areas of the District.

2. NCST vide notice dated 14.02.2025 sought facts and comments from the Collector and District Magistrate, Sri Alluri Sitharamraju Paderu within 30 days from receipt of the Notice. The Collector and DM, Alluri Sitharama Raju District vide his reply dated 15-03-2025 has informed the Commission that upon inquiry into the representation filed by Sri Chavalam Venkanna Dora alleging violation of Land Transfer Regulations in Schedule V areas, it was found that the subject lands in Sy. Nos. 18 and 88-2 of M. Ravitanka village were legally acquired and allotted under government schemes, with settlement pattas issued in favor of the Chattabattula family. The lands were either under cultivation or had been acquired for public projects like the Polavaram and Musurumitti Projects. Furthermore, the LTRP Case No. 79/2017 regarding these lands was disposed of on 20-02-2025 by the Special Deputy Collector (Tribal Welfare), Rampachodavaram in favor of the respondents (Chattabattula family), establishing that the petitioner has no rightful claim. Hence, the Collector recommended dismissal of the petition. This was forwarded to the petitioner vide NCST letter dated 25-03-2025.

3. NCST decided to discuss the issue with the authority and the petitioner on 09.04.2025. Accordingly, a Sitting Notice was sent on 27.03.2025. The Collector, ASR District vide letter dated 28.3.2025 has sought exemption and deputed Special Dy. Collector, Tribal Welfare, Rampachodavaram, ASR District to attend the sitting.

4. In the sitting, Special Dy. Collector, Tribal Welfare, Rampachodavaram, ASR District and petitioner were present. The petitioner reiterated his earlier submission and requested for justice. The Special Dy. Collector, Tribal Welfare, Rampachodavaram, ASR District has reiterated the facts submitted by Collector, ASR District in the matter and informed that the petitioner has no right on the subject land.

5. After discussion with the Special Dy. Collector, Tribal Welfare, Rampachodavaram, ASR District and petitioner, it was observed that as per the report submitted by the Sub'Collector, Rampachodavaram and also as per the order issued in LTRP No.7912017, dt:20'02.2025 in the court of Special Deputy Collector, Tribal Welfare, Rampachodavaram, Alluri Sitharama Raju District it is clearly found that the Petitioner Sri Chavalam Venkanna Dora is not having any right to the subject lands. However it is advised to the officials that the grievances of the STs need to be heard in a compassionate and empathetic manner.

6. No action is warranted on part of NCST. Hence, the case may be closed.
