## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/DEV-3459/TS/28/2024-ESDW

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Jetroth Harsha Naik, S/o Jetroth Bujja Naik, R/o Paranagar Village, Gummadila Mandal, Sangareddy District, Telanganaregarding lack of basic infrastructure in his village (Paranagar Village, Gummadila Mandal).

Date of the Sitting: 08/05/2025,12:30 PM Participants in the Sitting: As per Annexure

Shri Jetroth Harsha Naik, S/o JetrothBujjaNaik, R/o Paranagar Village, Gummadila Mandal, Sangareddy District, Telangana, belonging to the ST Lambadi Community, vide his petition dated 20.07.2024 has requested the Commission to direct the concerned officials to provide proper road facilities to his village. He stated that villagers must walk nearly 3.5 km through forest terrain, which becomes especially problematic during the rainy season, affecting the movement of agricultural machinery and emergency services. He highlighted the lack of streetlights, the difficulty faced by elderly and differently-abled persons in accessing government services, and cited tragic incidents, including the death of a villager due to ambulance delay and a pregnant woman dying en route to the hospital. Despite repeated representations, there has been no response from the authorities, prompting the present appeal.

- 2. NCST vide notice dated 27.11.2024 sought facts and comments from the Collector and DM, Sangareddy within 15 days from receipt of the Notice. The reply was not received. Hence, NCST decided to discuss the issue with the authority and the petitioner on 08.05.2025. Accordingly, a sitting notice was sent on 23.04.2025.
- 3. The Collector & DM, Sangareddy vide letter no. C2/NCST/3140/2024 dated 6.5.2025 has sought exemption and furnished the facts and comments on the issue raised by the petitioner. In the letter, it has been informed that the proposal for construction of road have been submitted to D/o Panchayati Raj and Engineering Department, Govt. of Telangana on 6.5.2025.
- 4. In the sitting, the petitioner was present. But no one was present on behalf of Collector & DM, Sangareddy District.
- After discussion with the petitioner and information furnished by the Collector & DM, Sangareddy District, the following recommendations were made and action taken thereon may be submit to NCST within 30 days from receipt of the minutes.
- a. The detailed report may be submitted on the profile of the village and action taken so far to redress their grievance especially in view of the upcoming rainy season.

b. The details of sanction of the work, progress of the tender process for the execution of the work may be submitted to NCST so as to know the expected date of completion.
