Shri S. Bhaskara Rao, Sub Treasury Officer, District Treasury, Srikakulam Andhra Pradesh belonging to ST category has submitted representation in 20.08.2021 alleging that he has been not considered for promotion to the Post Assistant Treasury Officer despite being fully eligible and already issuing promotion to his Juniors with consequential that he submitted that he had joined in Treasury Office, Srikakulam on 14.07.1999 benefits. He submitted that he had joined in Treasury Office, Srikakulam on 14.07.1990 benefits. He submitted that he had joined in the year 2006, whereas his junior got Thereafter, he got promoted in the next grade in the year 2006, whereas his junior Shri S. Venugopala Rao was promoted in the year 2020. But Treasury Officer as his Junior Shri S. Venugopala Rao was promoted in the year 2020. But his promotion has not been considered so far.

- 2. After various correspondence with the authority and petitioner, a sitting was held on 09.12.2024 at NCST with the concerned authority and petitioner. In the sitting, the following recommendations were made and minutes were forwarded to all concerned on 10.1.2025.
 - The pending court case could not be made a reason for denial of opportunity of the induction training to the petitioner which has affected his career.
 - The District of Srikakulam could not be taken as exclusive case when such restrictions of eligibility and qualifications are not made in other Districts.
 - The petitioner may be recommended for promotion along with all his batchmates
 - Treasuries and Accounts Department, Govt. of Andhra Pradesh vide letter 3. Ireasuries and Accounts Department, Govt. of Andria Pragesh vide letter dated 17.2.2025 has furnished the ATR and submitted that proposal for notional seniority have been submitted to Govt. on 3.2.2025. Orders are awaited from the Govt. Hence, the Hon'ble Member has decided to discuss the issue on 6.5.2025. Accordingly, a sitting notice issued to all concerned on 21.4.2025.
 - 4. In the sitting the Director, Treasuries and Account Department, Govt. of Andhra Pradesh was present on behalf of Principal Secretary, Finance Department, Govt. of Andhra Pradesh and Petitioner was also present. The Director, Treasuries and Account Andhra Pradesh and Petitioner was also present. The Director, Treasuries and Account Department, Govt. of Andhra Pradesh has provided their Department's letter no. FIN02-Department, Govt. of Andhra Pradesh is SEC-DTA dated 2.5.2025 and stated that the order of Govt. of Adhra Pradesh is still awaited. Accordingly, the discussion was not held with the authority and petitioner petitioner
 - In view of the letter dated 2.5.2025 of Treasuries and Account Department, Govt. of Andhra Pradesh, the following recommendations were made and action taken there on may be submit to NCST within 30 days from receipt of the minutes.
 - The D/ o Finance, Govt. of Andhra Pradesh may consider the proposal submitted by Treasuries and Account Department in the present case on priority basis.
 - The Travel Allowance and Special Leave may be reimbursed / granted in favor of the petitioner for attending the sitting on 09.12.2024 and 6.5.2025 at NCST, New Delhi, as per his entitlement.
