Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Durva Raju, s/o Linga, resident of Khaapri village, Asifabad Mandal, Kumuram Bheem Asifabad district regarding land issue.

Date of the Sitting: 18/06/2025, 12:10 PM

The petitioner, Durva Raju, s/o Linga, resident of Khaapri village, Asifabad Mandal, Kumuram Bheem Asifabad district, has stated that he was assaulted on 08-08-2024 and approached the police for registration of an SC/ST atrocity case. However, no action was taken by the concerned SI, CI, or SP, and no inquiry was conducted. He alleges that the police officials are supporting a local rowdy sheeter named Sadiq Fasha, a contractor, who has allegedly encroached upon tribal lands and is involved in several murders. Despite informing higher police officials, no protection or justice has been provided to the tribal community, and instead, the police are allegedly colluding with the accused for bribes. The petitioner claims that tribals in the region are being neglected by the police, who are acting in favour of influential wrongdoers. He fears for his life and states that justice is being systematically denied, warning that police may only respond after tribals are killed. He requests that an SC/ST atrocity case be registered against the accused and the matter be sent to court for trial.

2. The Commission issued notice to District Collector & Magistrate, Kumuram Bheem Asifabad and SP, Kumuram Bheem Asifabad vide NCST letter dated 10.02.2025 seeking facts and comments within 30 days.


3. Superintendent of Police, Kumuram Bheem Asifabad, vide his letter dated 24-02-2025, has informed the Commission that an enquiry was conducted by the ASP, Asifabad on the complaint of Sri Durva Raju, s/o Linga, r/o Kapri village, regarding alleged poisoning of his sorghum crops. The enquiry revealed that the disputed land was earlier cultivated by Korenga Ganesh, and later also ploughed by Durva Raju, leading to a land dispute. A village panchayat was called by elders, which Durva Raju failed to attend. Later, he filed a complaint alleging that his crops were poisoned by Korenga Ganesh and one Sadiq. However, inspection by police and elders showed that the crops had dried due to poor soil and lack of water, and no evidence of poisoning was found. The report concludes that the matter is a land dispute, and no proof exists to support allegations of malicious damage by the accused. This was sent to the petitioner vide NCST letter dated 07.03.2025.

4. The Commission has decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025.


5. In the sitting, ASP, Kumuram Bheem Asifabad was present on behalf of SP, Kumuram Bheem Asifabad and the petitioner was not present. The petitioner was attempted to be connected over on phone but he has not responded.

6. The authority has informed that the petitioner is claiming the said land to be the ancestral property of his wife and has not attended to the enquiry when the same was attempted by the Police and Revenue authorities and petitioner is not cooperating despite several attempts made by the authorities.

7. After discussion with the ASP, Kumuram Bheem Asifabad, it is concluded the no action is warranted on part of NCST as the petitioner has not been cooperating with the Police and Revenue authorities.
