Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Sunnam Nagamani, former ZPTC Member from Mulakalapalli regarding harassment of ST woman and her husband.

Smt. Sunnam Nagamani, former ZPTC Member from Mulakalapalli, vide her petition dated 17.03.2025, has alleged that false and defamatory posts were made against her on social media, particularly in public WhatsApp groups by individuals including M. Venkateswarlu, Somayya, and Yousuf, with the support of Mekala Nirmala and her son Mekala Naveen. She states that a civil case (OS No. 8/2022) filed by Nirmala against her husband S. Satyanarayana, a retired employee of Heavy Water Plant, is still under trial, and despite having no connection to the matter, court orders from the interim application (IA No. 1/2023) were allegedly stolen and shared in social media to damage her and her husband's reputation. She also alleged that her husband was kidnapped and threatened by Mekala Naveen and others to force payment, and no action was taken despite complaints to the Ashwapuram CI and Manuguru DSP. She asserts that as an ST woman public representative, she is being politically targeted and harassed and requests that SC/ST Atrocities Act charges be filed and legal action be taken against those responsible.

2. The Commission issued notice to Superintendent of Police, Bhadradri Kothagudem District vide NCST letter dated 25.04.2025 seeking facts and comments within 30 days. No reply has been received by the Commission.

3. The Commission decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025.

4. In the sitting, SDPO, Bhadradri Kothagudem was present on behalf of SP, Bhadradri Kothagudem and the petitioner joined via phone call.

5. The petitioner informed that she had been unnecessarily targeted though she is in no way concerned with the transactions happened between her husband and others. They are defaming her with malafide intentions as she is in politics.

6. The authority informed that the matter is in subjudice.


7. After discussion with the SDPO, Bhadradri Kothagudem and the petitioner, it is found that no action is warranted on the part of NCST and the case may be closed.
