Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Bhukya Alwar Swamy, Nadigadda Thanda Miyapur Sherilingampally regarding CRPF camp causing distress to STs.

The petitioner Shri Bhukya Alwar Swamy, Nadigadda Thanda Miyapur Sherilingampally has stated that around 5,000 tribal residents of Nadigadda Tanda, under Miyapur village, Serilingampally Mandal, Ranga Reddy District, Telangana, have been residing there since before independence and were provided with basic facilities by the government, including roads, drainage, water, electricity, and a hospital. However, since 2016, a CRPF camp has been set up at the entrance of the Tanda, and CRPF personnel are allegedly harassing the residents, claiming the land belongs to the central government. They are said to be intimidating the tribal people, restricting basic movement and supplies, and threatening eviction, causing severe mental distress. The petitioner has requested the Commission's intervention to stop the harassment and to ensure a compound wall is built to prevent CRPF intrusion.

- 2. NCST vide notice dated 01.04.2025 sought facts and comments from the SP, Rangareddy within 30 days.
- 3. The Commission decided to discuss the issue with DG, CRPF, District Collector and Magistrate, Rangareddy and Custodian of Enemy Property of India and the petitioner on 17.6.2025. Accordingly, a sitting notice issued on 9.6.2025.
- 4. In the sitting, ADG, CRPF and Deputy Collector, Rangareddy were present on behalf of DG, CRPF and Collector, Rangareddy respectively. The petitioner was also present.
- 5. The petitioner reiterated their grievances. During 2016 a meeting was conducted by MLA where in the police officials and temporary boundary was constructed so as to avoid any new encroachments. However every time the CRPF team changes once in 1-2 years, they are creating issues and preventing any Government interventions like laying of the road etc.,
- 6. The ADG, CRPF informed that they are following the orders of the Central Government as the land comes under the jurisdiction of Central Government. They have no problem vacating the land or any other changes if such orders are given. The DC, Rangareddy informed that 480 acres of land is there in Survey No.28. Some part is handed over to Hyderabad Metro corporation and Nadigadda and 5 other habitations are currently existing in the remaining land with over 1000 families exisiting in 25 acres.
- 7. After discussion with the officials of CRPF and DC, Rangareddy and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.
- The authorities may permit infrastructure in the already existing habitation as Roads, Drinking water, electricity, Housing are basic minimum infrastructural requirements as the ST people are living there for generations. Necessary actionmay be taken by the Revenue Department.
- Further encroachments may be curtailed as decided by the Central and State Governments.
- Custodian of Enemy property/ Deputy Commissioner, Enemy property may attend the next scheduled date of hearing
