

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Bhukya Papa Nayak, S/o Bhamla, a Scheduled Tribe farmer and resident of Kotha Thanda village, Tekulapalli Mandal, Bhadradri Kothagudem District regarding harassment and humiliation by the local police.

Shri Bhukya Papa Nayak, S/o Bhamla, a Scheduled Tribe farmer and resident of Kotha Thanda village, Tekulapalli Mandal, Bhadradri Kothagudem District, vide his petition dated 24.03.2025 has alleged that his ancestral land measuring 5 acres, which he has been cultivating for 40 years, is registered in his name and he has been receiving Rythu Bandhu benefits as a legal pattadar. On 03-03-2025, he was called to the Tekulapalli Police Station by the Circle Inspector, Shri Tatipamula Suresh, without revealing the complainant's identity, and was abused and illegally detained. Simultaneously, police house-arrested his two sons, prevented them from leaving the house, and facilitated the illegal trespass into his farmland by one Lakkineni Shyam (non-tribal) and about 12 others in a tractor without a number plate, who destroyed the fencing stones and caused damage to his field. He claims a loss of ₹5 lakhs and serious mental agony and humiliation. He alleges that this act of harassment was done in collusion between the Circle Inspector and the non-tribal and has pleaded for protection.

2. The Commission issued notice to District Collector & Magistrate, Bhadradri Kothagudem District and Superintendent of Police, Bhadradri Kothagudem District vide NCST letter dated 02.05.2025 seeking facts and comments within 30 days. No reply has been received by the Commission.


3. The Commission has decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025.

4. In the sitting, SDPO, Bhadradri Kothagudem was present on behalf of SP, Bhadradri Kothagudem and the petitioner was also present. The petitioner informed that though he was having all the valid legal documents of patta pass book from 2012, he and his brother were threatened and harassed. When his brother approached High court a status quo was ordered by Hon'ble Court but still the non tribals have illegally entered into the land. When the SP was approached over the alleged harassment, he has entrusted the same to DSP Shri Banuchander, how ever it remain unsettled.


5. The authority informed that as per the reports of the MRO and Revenue authorities Sri Lakkineni Shyam was shown as occupying the land from 1985-2017. In 15 acres of disputed land in survey number 133/1, it is affecting 2 STs and 3 SCs.

6. After discussion with the SDPO, Bhadradri Kothagudem and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.

- Upon the verification of documents it is found that the petitioner is holding the valid patta passbooks and the report furnished by the MRO appeared to be contradictory.
- An SC ST(POA) may be invoked on the non tribals who have forcefully hemmed in and confined the petitioners family and damaged the fencing of the petitioners land.
- A detailed enquiry may be made by the Revenue authorities to settle the rightful claim.
