

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Dr. Kalyan Nayak, BJP ST Morcha State President, Hyderabad regarding alleged illegal mining being carried out in Survey No. 97 of Salarpur Thanda, Kadthal Mandal, Rangareddy District and Chipununthala Forest area.

Dr. Kalyan Nayak, State President, BJP ST Morcha, Hyderabad vide his petition dated 29.11.2024 has alleged that illegal mining is being carried out in Survey No. 97 of Salarpur Thanda, Kadthal Mandal, Rangareddy District and Chipununthala Forest area by one P. Katthaalu, with the support of local mining and forest officials. He has claimed that false coordinates were submitted to secure a mining lease on 03.07.2021, and that officers including the district surveyor and mining surveyor fraudulently allowed the mining by manipulating documents. He also stated that tribal thandas such as Rekulakunta, Balaji Nagar, Chellampally and PaathaKunta are facing environmental pollution due to the illegal activity, and locals are being threatened by the mining group led by P. Katthaalu, an ex-Naxalite. He has demanded strict action against the responsible officers.

2. NCST vide notice dated 07.03.2025 sought facts and comments from the Collector and DM, Ranga Reddy within 30 days from receipt of the Notice.

3. The Collector & District Magistrate, Ranga Reddy District vide letter no. C1/NCST/1045/2025 dated 17.04.2025 has informed that the representation filed by petitioner, regarding illegal mining in the Chipununthala Forest area, Sy. No. 97 of SalarpurThanda, Kadthal Mandal forwarded the Commissioner of Police, Cyberabad District Forest Officer, Ranga Reddy District; Member Secretary, Telangana Pollution Control Board; Assistant Director, Department of Mines and Geology; Revenue Divisional Officer, Kandukur Division and Tahsildar, Kadthal Mandal for submission of facts and action taken report in the matter.

4. There were no communication from the authorities, Hence, a sitting was fixed with District Collector & Magistrate, Ranga Reddy and petitioner on 24.5.2025 at Dilkusha Guest House, Hyderabad, which was postponed as the concerned authority was not present. Therefore a sitting was again fixed on 4.6.2025 to discuss the issue with the District Collector and Magistrate, Ranga Reddy, Member Secretary, Telangana State Pollution Control Board, Hyderabad, Director, D/o Mines & Geology, Hyderabad, Principal Chief Conservator of Forest, Hyderabad and petitioner. Accordingly, a sitting notice issued on 28.5.2025.

5. In the sitting, representative from District Magistrate and Collector, Ranga Reddy, Joint Director, Mines & Geology and petitioner were present. But there was no communication from Telangana State Pollution Control Board, Hyderabad and Principal Chief Conservator of Forest, Hyderabad. The petitioner reiterated his earlier submission and stated that report submitted by authority are not satisfactory. The officers present in the sitting informed that the issue raised by the petitioner relates with the various Departments of the State Govt.

6. After discussion with the officers of the Govt. of Telangana and petitioner, the following recommendations were made and action taken report there on be submitted to NCST within 30 days from receipt of the Minutes.



- A Joint survey may be conducted by the team comprising Officers of District Administration, Forest Department, Telangana Pollution Control Board, Department of Mines and Geology duly giving a notice of prior intimation of scheduled date and time of survey and survey may be done in presence of the representatives of the affected villages and area to assess the facts in the matter.
- The report of the same may be submitted to NCST for further action.
