Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Kota Shivashankar, State General Secretary of Telangana SC, ST, BC, Minority Vidyarthi Yuvajana Sangam regarding harassment of ST officer.

Date of the Sitting: 18/06/2025, 02:00 PM Participants in the Sitting: As per Annexure

Shri Kota Shivashankar, State General Secretary of Telangana SC, ST, BC, Minority Vidyarthi Yuvajana Sangam, vide his petition dated 02.02.2025, has alleged that Shri Balaram, the current Chairman and Managing Director of Singareni Collieries Company Limited (SCCL) and a tribal officer, is being unjustly harassed and mentally disturbed by one G.K. Sampath through malicious complaints and false allegations, which amount to offences under the SC/ST (Prevention of Atrocities) Act. The petitioner claims that G.K. Sampath, who was earlier removed from service due to corruption and vigilance cases, is engaging in a vendetta against SCCL and its CMD by misusing legal and administrative mechanisms, including filing of baseless complaints with senior government authorities. The petitioner has requested that a case under the SC/ST Atrocities Act be filed against Sampath and that the NCST intervene to protect honest tribal officers from such targeted harassment.

- 2. The Commission issued notice to Superintendent of Police, Bhadradari Kothagudem District vide NCST letter dated 25.04.2025 seeking facts and comments within 30 days. No reply has been received by the Commission.
- 3. The Commission has decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025.
- 4. In the sitting, SDPO, Bhadradri Kothagudem was present on behalf of SP, Bhadradri Kothagudem and the petitioner was also present.
- The petitioner informed that one Mr. GK Sampath who has been earlier removed from service due to corruption and vigilance cases, is engaging in a vendetta against SCCL and its CMD by misusing legal and administrative mechanisms.
- 6. After discussion with the SDPO, Bhadradri Kothagudem and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.
- a. SC/ST Atrocities Act be invoked against Shri. Sampath if it is found that he has been attributing baseless allegations against the presnt CMD of Singareni Collieries, Police Department may take necessary action regrding that.

b. Suitable mechanism may be established to protect honest officers from such targeted harassment and at the same time protection to the whistle blowers who genuinely bring the corruption to the focus of public attention.
