## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/SER-1717/AP/73/2024-RO-BHUV

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri B. Chekre Naik, General Secretary, All India Central, PSUs & State Govt. ST Employees Welfare Association regarding regularization of service and promotion of Shri T. Bhaskar.

Shri B. Chekre Naik, General Secretary, All India Central, PSUs & State Govt. ST Employees Welfare Association, vide his representation dated 25.06.2024, has requested the Commission's intervention for regularization of service and declaration of probation of Shri T. Bhaskar (ST), Deputy Director, DIO, Ananthapuramu in the cadre of Deputy Director w.e.f. 19.08.2021, and for his promotion to the post of Joint Director, APGLID. He has been serving in the post on Ad-hoc basis for over three years, with regular increments sanctioned, yet his service has not been regularized. Despite availability of two clear vacancies for the post of Joint Director, he has been denied promotion while his juniors have already been promoted, causing him mental agony and deprivation of his legitimate right. It is alleged that the Department is misusing the pendency of court cases and procedural excuses to withhold the probation and promotion, even though his case is not directly impacted by pending litigations post final seniority list. The petitioner has urged the Commission to direct the Chief Secretary, AP, to issue necessary orders to the Finance Department and Director of Insurance to regularize Shri T. Bhaskar's service and promote him, given that he is the only senior and eligible ST officer in the zone.

- 2. The Commission issued notice to Vice Chairman and Managing Director, APSRTC vide NCST letter dated 22.01.2025 seeking facts and comments within 30 days. No reply has been received from the authority. A reminder letter was sent on 14.06.2024 as well.
- 3. The Commission decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025.
- 4. In the sitting, Director, APGLI was present and the petitioner was also present.
- 5. The petitioner informed that there were 22 posts of ADs in composite state of Andhra Pradesh but now only 6 of them remained- 4 in Telangana and 2 in AP. The court case which the Government is referring to relates to the aggrieved from the State of Telangana and its outcome will have no impact on his promotion.
- 6. The authority informed that the final allocation of ADs has not happened and the seniority is to be fixed in AD Cadre and there may be a possible effect if there is any change of seniorities of ADs. The authorities further informed that inspite of continous persuasion the case did not reach the bench in Hon'ble High Court.
- 7. After discussion with the Director, APGLI and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.
- Conditional promotion may be given subject to the outcome of the Hon'ble High court case as the case pertains
  to State of Telangana and not Andhra Pradesh and as the petitioner is not affected by the possible order.
- As the petitioner is alredy performing the duties of DD on adhoc basis, the same may be regularlized and
  probtion declared by the competent authority, ED and proposal for adhoc JD promotion may be submitted to
  the Government for consideration of the same by the Principal Secretary of the Department.
