Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri B. Chekere Naik, State General Secretary, All India Banjara Seva Sangh regarding rights and lands of the Nakkala Shikari Tribal community in Tirupati District, Andhra Pradesh.

Date of the Sitting: 18/06/2025, 11:00 AM

Shri B. Chekere Naik, State General Secretary, All India Banjara Seva Sangh, vide his petition dated 26.09.2024, has requested the Commission's intervention to protect the rights and lands of the Nakkala Shikari Tribal community in Tirupati District, Andhra Pradesh. He states that despite being assigned lands by the government in 1977 (as per Tahsildar's ROC A/28/2018 and DRO's order dated 13.01.2020), these lands have been illegally occupied by upper caste and politically influential individuals, resulting in violent attacks, including deaths and injuries to tribal members. The police authorities have failed to provide protection or justice to the community. Despite several representations, no concrete action has been taken. The petitioner seeks the Commission's directions to restore the assigned lands, investigate the violent incidents, and take action against anti-social elements, ensuring the protection and justice for the Nakkala Shikari ST community.

2. The Commission issued notice to District Collector & Magistrate, Tirupati, District Forest Officer, Tirupati, Superintendent of Police, Tirupati Urban Police District vide NCST letter dated 13.02.2025 seeking facts and comments within 30 days. No reply was received from the authority. The Commission decided to discuss the issue with the authority and the petitioner on 18.06.2025. Accordingly, a Sitting Notice was sent on 10.06.2025

3. The District Collector has sought exemption in view of Hon'ble PMs visit to the State of AP. In the sitting, Tahsildar was present on behalf of District Collector and Magistrate, Tirupati and SDFO was present on behalf of DFO, Tirupati. The petitioner was also present.

4. The petitioner informed that around 560 acres of land is assigned to the Nakkala Shikari families in 1977 and 1988. However no facilities were provided at that time. They being nomadic communities at that time, have seasonally migrated for livelihood, those lands were encroached by others and now only an extent of 66 acres is available in that area.

5. The authority informed that the assigned lands were sold by the assignees, hence those assignment pattas were cancelled by the Government and they are reclaiming now.

6. After discussion with the Tahsildar and SDFO, Tirupati and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.

- The Nakkala Shikari families residing in that area among those of 112 families who were initially assigned the land may be identified and assigned the land from among the remaining vacant land of 66 acres.
- The infrastructure facilities of housing, roads, electricity, drinking water etc may be provided and make the area livable for them.
- Necessary outsourcing employment may be created in the near by Universities/ PSUs/ TTD for the eligible youth / women from Nakkala Shikari families to address migration and make them settle at a place.




