

## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Sri B Nageswara Rao, Sr. Assistant working in Sri Durga Malleshwara Swamy Devasthanam, Vijayawada regarding denial of promotion inspite of High Court in his favour.

Sri B Nageswara Rao working as Sr. Assistant in Sri Durga Malleshwara Swamy Varla Devasthanam, Indrakeeladri, Vijayawada has represented that he was denied the promotion from senior assistant to superintendent cadre due to non implementation of Hon'ble High court Order and non implementation of Roster point as per existing GO 77 of GAD.

2. In the sitting held on 08.04.2025, the following recommendations were made-

- "As 8 months have already elapsed without any reason though it has been found that there is no loss to the Department, the Commissioner endowments may immediately conclude the case.
- The petitioner may appeal before the commissioner, Endowments if any punishment or withholding of increment is imposed and Commissioner, Endowments may examine it and consider for lifting the censure and promote him.
- As there are similar cases of promoting ie, Bhavya from Jr. Asst to Sr. Asst and several others like Siva reddy, Kalyani, Raju etc as mentioned by the petitioner, the petitioner may also be promoted.
- The Travel Allowance and Special Leave may be reimbursed / granted in favour of the petitioner, as per the entitlement, by the Endowments Department, Govt. of Andhra Pradesh, Vijaywada."

3. The Commission again decided to discuss the issue with the authority and the petitioner on 23.06.2025. Accordingly, a Sitting Notice was issued on 18.06.2025. The petitioner, Shri B. Nageswara Rao, attended the sitting. However, the authority, in compliance with the minutes of the sitting held on 08.04.2025, communicated the proceedings vide Rc. No. A1/11026(43)/7/2025 dated 20.06.2025, wherein the imposed punishment of censure was set aside, as no financial loss was caused to the institution and the Executive Officer of the said Devasthanam failed to provide valid reasons for imposing the censure.

4. The petitioner informed that he was transferred to Penuganchiprolu during his medical leave, in the same cadre of Senior Assistant, even though he is eligible for promotion to the post of Superintendent in Sri Durga Malleshwara Swamy Varla Devasthanam, Indrakeeladri, Vijayawada. He stated that his basic grievance regarding promotion remains unresolved.

5. After discussion with both the sides, the following recommendations are made, and an Action Taken Report (ATR) may be submitted within 15 days:

- a. The petitioner's claim may be re-examined, as he is eligible for promotion since the punishment of censure has been set aside.
- b. The petitioner's request for promotion to the cadre of Superintendent in the same temple may be examined as per rules in vogue.
- c. TA and special casual leave may be sanctioned for the petitioner for attending the hearing
