NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Smt. Bhukya Badri regarding illegal encroachment of her land.

Date of the Sitting: 23/06/2025, 03:40 PM Participants in the Sitting: As per Annexure NCST/DEV-4910/TS/434/2025-RO-BHUV/RU-III

The petitioner, Smt. Bhukya Badri, W/o Ramji, R/o Chunchupalli Village, Bhadradri Kothagudem District, Telangana, vide her petition dated --/03/2025 has alleged that her patta land in Sy. No. 157/15, measuring Ac.4.19 guntas, located in a PESA/Agency area is being illegally encroached upon by two individuals – Dandamudi Ravinder and Bikkasani Nageswara Rao – with political influence, who are also using the land for real estate ventures despite a status quo order by the Hon'ble Supreme Court (C.No.785/2025) and cancellation of police protection by Telangana High Court (CRP-3464/2023). The petitioner states that despite these court orders and boundary markers by revenue officials, the encroachers have demolished her fencing and house structures, prevented her from accessing her land, and issued life threats. She highlights that her land falls under the 1/70 Act, which prohibits such sales or ventures in agency areas, and accuses local police of inaction due to political pressure. She seeks intervention to ensure legal action against the accused, protection of her land, and recommendation to the District Collector to transfer the mobile court directions for proper enforcement.

- 2. The Commission issued notice to District Collector & Magistrate, Bhadradari Kothagudem District vide NCST letter dated 02.05.2025 seeking facts and comments within 30 days. No reply has been received. The Commission has decided to discuss the issue with the authority and the petitioner on 23.06.2025. Accordingly, a Sitting Notice was sent on 20.06.2025.
- 3. The authority ie, The District Collector and Magistrate, Bhadradri Kothagudem District has attended the sitting. The petitioner Smt. Bhukya Badri has also attended the sitting.
- 4. The petitioner informed that her earlier submissions stating that patta land in Sy. No. 157/15, measuring Ac.4.19 guntas, located in a PESA/Agency area is being illegally encroached upon by two individuals Dandamudi Ravinder and Bikkasani Nageswara Rao.
- 5. The authority has informed that the case is active at mobile court at Bhadrachalam and will be pursued for expeditious trial so as to take appropriate action.
- 6. After sitting to the petitioner and authority, the following recommendations are made and ATR may be submitted in 30 days.
 - a. Alternate land may be shown to the petitioner as she is claiming to be occupying the said assigned land since 1985 which is auctioned to private individuals prior to 1970.
 - b. As the case O.S No.406 of 2021 is pending before the Special Assistant agent and Sub divisional magistrate(Mobile court) at Bhadrachalam, the same may be expedited for logical conclusion and justice to the petitioner.
