Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri D. Rakesh and Shri Hanumanth Naik, Moinabad, Ranga Reddy regarding collecting an amount exceeding the Government Order issued by the Telangana State Government from students belonging to the weaker section community, particularly Scheduled Tribes.

The petitioner, Shri D. Rakesh and Shri Hanumanth Naik, Moinabad, Ranga Reddy-500 075 (Telangana), vide their representations/mails dated 09.11.2024, have complained against the management of JB Institute of Engineering and Technology, Yenkapally, Moinabad for collecting an amount exceeding the Government Order issued by the Telangana State Government from students belonging to the weaker section community, particularly Scheduled Tribes.

In the sitting held on 06.05.2025, the Commission stated-

"After discussion with the Registrar and Director, JNTU, Hyderabad and Principal, JBIET, RR District, the following recommendations were made and the action taken there on may be submitted within 30 days from receipt of the

- The Universities(JNTU, Osmania, Kakatiya) may ensure that the Engineering Colleges under their affliation shall adhere to the guidelines of fee structure prescribed by the Universities.
- All those Colleges which violate the norms and guidelines may be blacklisted and the stringent actions may be taken on the managements by the Higher Education Department.
- The University may examine all the lapses of violation of fee structure by the Private Engineering Colleges that have happened in the last 5 years and ensure that the certificates of candidates retained by the colleges shall be returned to the candidates. '
 - The Registrar, JNTU Hyderabad, vide his letter dated 28.05.2025 has informed the Commission that in response to the Commission's minutes regarding excess fee collection in violation of Government norms, the University has forwarded the Commission's minutes to the Registrars of Osmania University and Kakatiya University. Additionally, instructions have been issued to all Principals of Constituent and Affiliated Colleges of JNTU Hyderabad to strictly follow Government and University-prescribed fee collection guidelines and not to retain student certificates after program completion.
 - The Commission again decided to discuss the issue with the authority and the petitioner on 23.06.2025. Accordingly, a Sitting Notice was sent on 18.06.2025. The Registrar, OU, and Controller of Examinations, OU, attended the sitting. The petitioner was also present.
 - The petitioner informed that violations are occurring in the colleges affiliated to OU and JNTU, where excess fees are being collected and certificates of candidates unable to pay the fees are being withheld.
 - The authorities informed that colleges are mandated to follow the fee structure prescribed by the Telangana Fee Regulation Committee. They stated that there is a classification of category 1, 2, and 3 colleges and that an academic audit is conducted every year to monitor compliance with the guidelines prescribed by the Fee Regulation Committee and AICTE. They further mentioned that they do not have any direct role in enforcing compliance.
 - After hearing both the petitioner and the authorities, the following recommendations were made:
- The University may submit details of colleges affiliated to Osmania University, their classification, the fee structure followed, academic audits, and other monitoring mechanisms for ensuring compliance by the colleges.
- b. A grievance portal may be developed to receive online complaints regarding fee-related and other issues and to ensure timely resolution.
- The Commission may visit some of these engineering colleges shortly and interact with students to ascertain the facts concerning grievances related to facilities and violations of the prescribed fee structure.
