## **National Commission for Scheduled Tribes**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri V. Hathiram, Reserve Inspector of Police, Nirmal District regarding accelerated promotion in light of dedicated field service

Shri V. Hathiram, Reserve Inspector of Police, Nirmal District, attached to PTC Amberpet, vide his representation dated 20.06.2024 has submitted that he hails from a depressed Scheduled Tribe community and has served over 20 years in the Police Department, beginning as a Police Constable in 2003. He has actively participated in anti-Maoist operations in Warangal and Khammam districts, contributing to significant recoveries and exchange of fire incidents, and has earned numerous rewards including 30 Cash Rewards, 37 GSEs, 63 Commendation Letters, 1 Appreciation Letter, and Utkrista Seva Pathakam. He also served as a trainer for multiple forces and conducted training at national-level institutions. Highlighting his dedicated field service, life-risking operations, and clean service record, he has requested the Commission to recommend his case for accelerated promotion to the rank of Assistant Commandant, citing a precedent under GO Rt No. 2291 dated 20-12-2021 where a similar promotion was granted.

- 2. NCST vide notice dated 11.03.2025 sought facts and comments from the DGP, Gov of Telangana within 30 days.
- 3. The Director General of Police, Telangana vide his letter dated 05-06-2025 has informed the Commission that the representation of Sri V. Hathiram, Reserve Inspector (AR), Nirmal District, currently attached to PTC Amberpet, seeking accelerated promotion to DSP (AR) on the basis of his anti-extremist field performance, was forwarded to DG, Intelligence for specific remarks. The DG, Intelligence, vide letter dated 27-08-2024, noted that although the petitioner was involved in three encounters resulting in the death of 8 extremists, his individual contribution was not significant. It was further stated that his prior service as PC (Civil) and RSI/RI lacks any outstanding performance warranting accelerated promotion. Based on these observations, the DGP has not recommended his case for promotion and the representations have been lodged. The Commission has been requested to consider these facts while disposing of the petition.
- 4. The Commission decided to discuss the issue with the authority and the petitioner on 23.06.2025. Accordingly, a Sitting Notice was sent on 20.06.2025. In the sitting, on behalf of the DGP, State of Telangana, Sri Anil Kumar, IPS, Additional Director General of Police, Personnel, Office of the Director General of Police, Telangana State, and Sri Srininvas, IPS, Co-ordination, represented the Police Department. The petitioner, Shri Hathiram, Reserve Inspector of Police, also attended the sitting.
- 5. The petitioner informed that he rendered continuous excellent service in the anti-Maoist field as a Police Constable and later as RSI, grossly neglecting his family and personal life, and also risking his life, but his case was not considered for accelerated promotion. He is now working as Reserve Inspector of Police, having completed more than 7 years, and has become eligible for promotion as Deputy Superintendent of Police.

- 6. The authority informed that Sri V. Hathiram rendered work in the anti-Maoist field while he was serving as a Police Constable, and later got selected as RSI. The said work was done long back, and thereafter he did not render any such work. Further, a panel of experts will evaluate the candidates and shortlist them based on their involvement and participation in the frontline, which includes the threat faced in hostile situations and not just being part of the team. It was further mentioned that his regular promotion will happen as per his seniority list.
- 7. After hearing both the petitioner and the authority, the following recommendations were made by NCST. ATR may be submitted within 60 days from the receipt of the Minutes.
- a. It is evident that the petitioner performed outstandingly in the anti-Maoist field as a Police Constable and also as RSI.
- b. Further, there is a precedent of such accelerated promotion in the instance of G.O.Rt.No. 2291, Home (Special) Department, dated 20-12-2021, through which the Government of Telangana State, considering the work done by an officer named Sri M. Venkateshwarlu during 1992–2005, i.e., 16 years ago, in the anti-Maoist field, granted him accelerated promotion in the above Order to the rank of Superintendent of Police (Non-Cadre).
- c. TA and special casual leave may be sanctioned for the petitioner for attending the hearing
- d. Hence, the Department may examine the claim of Sri V. Hathiram, Reserve Inspector of Police, for accelerated promotion on the lines of G.O.Rt.No. 2291, dated 20-12-2021. (Copy enclosed)
