

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Jatoth Venkatesh, s/o Rajaram, an ST (Lambada) resident of Ramachandratanda, Peddavangara Mandal, Mahabubabad District regarding cheating, assault and lack of action by the police.


Shri Jatoth Venkatesh, s/o Rajaram, an ST (Lambada) resident of Ramachandratanda, Peddavangara Mandal, Mahabubabad District, vide his petition dated 25.07.2024, has stated that Balasubramanya Kumar (of Venkatapuram Mandal, Mulugu District), along with Kadem Sampath and Kadem Someshwara Rao (residents of Charla Mandal, Bhadradi Kothagudem District), assaulted him on 09.04.2024. An atrocity case was registered at Dummugudem Police Station (FIR No. 63, dated 07.05.2024), but even after nearly three months, no progress has been made. He alleges that the accused took money from him for selling agricultural land but failed to return it, and when asked, assaulted him. He further claims that CI Ashok at Dummugudem police station initially refused to register the complaint and supported the accused, and only after he approached the ASP Bhadrachalam, was the case registered. Despite repeated follow-ups with both the ASP office and the police station (10-15 times), no information or action has been taken. He has requested the Commission to intervene and ensure strict legal action against the accused.

2. The Commission issued notice to Superintendent Of Police, District - Bhadradi Kothagudem vide NCST letter dated 26.12.2024 seeking facts and comments within 15 days.

3. Superintendent of Police, Bhadradi Kothagudem District vide his letter dated 04.02.2025 has informed the Commission that on the basis of the complaint filed by Shri Jatoth Venkatesh, a case was registered at Dummugudem Police Station (FIR No. 63/2024, dated 07.05.2024) under IPC sections 294(b), 323 read with 34, and sections 3(1)(r)(s), 3(2)(va) of the SCs & STs (POA) Act, 1989 and its Amendment Act, 2015. The petitioner alleged that Bala Subramanya Kumar, Kadem Sampath, and Kadem Someshwara Rao took ₹50 lakhs from him promising land sale, and later abused and assaulted him when he demanded repayment. He also alleged that CI Ashok discouraged registration of FIR. Upon enquiry, the ASP Bhadrachalam found that the incident occurred near Gangolu temple, and after due process, the case was taken up for investigation. The charge sheet has been prepared and is under vetting by the Special Public Prosecutor. It was also concluded that the allegations against CI Ashok were found to be false and baseless. This was sent to the petitioner vide NCST letter dated 02.05.2025.

4. The petitioner, vide his rejoinder dated 19.05.2025 has stated that despite registration of FIR No. 68 dated 07.05.2024 at Dummugudem Police Station under the Atrocities Act, no justice has been rendered to him till date. He alleges that the accused are threatening his witnesses, caused him to lose his job, and continue to pose a threat to his life. He also claims that the accused snatched his transaction records on the day of the incident and have not returned the ₹50 lakhs taken from him. He has expressed helplessness due to severe financial distress and requested the Commission to ensure recovery of his money, cancellation of bail if granted to the accused, and provision of financial assistance through the ST Commission.

5. The Commission decided to discuss the issue with the authority and the petitioner on 23.06.2025. Accordingly, a Sitting Notice was sent on 18.06.2025. The authority ie, the District Superintendent of Police, Bhadradi Kothagudem has attended the sitting. The petitioner attended over phone call.

6. The petitioner has informed that he used ₹20 lakhs from postal accounts and ₹30 lakhs of his own personal funds and invested in agricultural land which was allegedly not registered in his name. The money was not returned by the non-ST individuals in Venkatapuram and Charla Mandals, and when he demanded repayment, he was threatened and assaulted. He further stated that the police initially did not cooperate in registering the FIR, and even after its registration, no progress was made despite repeated requests.

7. The authority has informed that Shri Jatoth Venkatesh committed fraud by diverting depositors' money from postal accounts and investing it in sand ramps, for which he was suspended from the Postal Department. They further stated that the matter is unrelated to any agricultural land transaction. The non-ST individuals alleged that he failed to honour the contract and presented evidence claiming he had cheated them.

8. After discussion with the District Superintendent of Police, Bhadradi Kothagudem, and the petitioner, the following recommendations are made, and an ATR may be submitted within 30 days:

- a. As public money belonging to postal depositors is involved, the same needs to be recovered on time and paid back to Postal Department.
- b. The petitioner may submit a detailed statement of online fund transfers made to the alleged defaulters as evidence to the police.
- c. A detailed enquiry may be conducted once again, and appropriate steps may be taken for the recovery of the said amount.


