Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok NayakBhawan, New Delhi in the case of Shri Gugulothu Raju and Shri Gugulothu Ravi, residents of Rudragudem village, Nallabelli Mandal, Warangal District, Telangana regarding harassment by police and other individuals

(NCST/ATY-2060/TS/172/2024-RO-BHUV/RU-III)

Date of the Sitting: 05/06/2025,3:40 PM

Shri Gugulothu Raju and Shri Gugulothu Ravi, residents of Rudragudem village, Nallabelli Mandal, Warangal District (Telangana) vide their petition dated 23-12-2024 have stated that they work as agricultural laborers and were engaged by Sri Vakkala Venkatesh for labour work on his land. On 18-12-2024, they removed trees and bushes as per his direction. However, on 22-12-2024, they were called to the Nallabelli Police station by SI Sri V. Govardhan and were subjected to caste-based abuse, physical assault and threats by the SI along with Tout Reddy Rajireddy. They allege that they were illegally detained, forced to sign blank papers and further humiliated when they attempted to report verbal abuse by Rajireddy and his wife Vijaya. The petitioners seek action against SI Govardhan, Rajireddy and Vijaya for caste-based discrimination, atrocities, physical assault and forced signatures. Hence, do the justice.

- 2. NCST vide notice dated 01.01.2025 sought facts and comments from the Superintendent of Police, Warrangal District within 30 days from receipt of the notice.
- 3. Commissioner of Police, Warangal vide letter dated 22.03.2025 & 25.3.2025 had informed that the petitioners, Shri Gugulothu Raju and Shri GugulothRavinder @ Ravi, residents of Rudragudem, Nallabelly Mandal, Warangal, alleged that they were called to the police station on 22.12.2024 on the complaint of Touti Reddy Raji Reddy, where SI Govardhan of Nallabelly PS allegedly abused and assaulted them using caste-based slurs and forced them to sign papers without consent. They also alleged further harassment by Touti Reddy Raji Reddy and his wife Vijaya. Upon enquiry by the Assistant Commissioner of Police, Narsampet, it was found that the petitioners were engaged by one Vakkala Venkatesh for labour work in his land and the allegations of abuse or threats by SI Govardhan or the complainants were not substantiated. The petitioners later admitted that they were neither beaten nor abused and that they were made to sign a petition by their caste elder without knowledge of its contents. Hence, the allegations were found to be false and baseless, and no action was deemed necessary.
- 4. The Commission decided to discuss the issue with the authority and the petitioner on 05.06.2025. Accordingly, a Sitting Notice was sent on 30.05.2025.
- 5. The Commissioner of Police, Warangal vide letter dated 2.6.2025 has sought exemption and deputed ACP, Narsampet to attend the sitting.

- 6. In the sitting, the ACP, Narsampet was present and petitioner joined via phone. The petitioner alleged that the behaviour of SI Govardhan of Nallabelly Police Station towards the labours are not good. The ACP Nersampet has explained the facts an comments submitted by Commissioner of Police, Warangal to the NCST.
- 7. After discussion with the ACP, Narsampet and petitioner, the following recommendations were made and action taken report thereon may be submitted to NCST within 30 days from receipt of the minutes.
- The Police Administration may sensitise the police personnel about the Scheduled Tribes and their constitutional safeguards.

• The SI (Shri B. Govardhan) of Nallabelly Police Station may be transferred to other Police Station of District.
