Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member. National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri A. Thirupathi, Junior Assistant regarding harassment at workplace

Shri A. Thirupathi, Junior Assistant in the office of the Project Officer. ITDA. Eturnagaram, vide his petition dated 15.10.2024 has alleged repeated and arbitrary deputations across distant districts causing personal and professional hardship. He claims these actions are in retaliation for being a witness in a harassment case against two senior officials, namely Sri J. Vasanth Rao and Sri TVR Damodara Swamy, who allegedly harassed a female employee and also abused him personally. The petitioner asserts that despite approaching police authorities under the SC/ST (PoA) Act and submitting representations to higher officials, no action has been taken due to the influence of the accused. He has requested for justice.

- NCST vide notice dated 25.11.2024 sought facts and comments from the Collector and DM, Mulugu and Superintendent of Police, Mulugu within 15 days from receipt of the Notice.
- The Superintendent of Police, Muluqu District, vide letter no. 1760/G1-MLG/2024 dated 19.12.2024 has informed that a detailed enquiry was conducted based on the complaint of Sri A. Thirupathi, Junior Assistant, ITDA Eturnagaram. The allegations included verbal abuse, illegal demands for money, intentional delay in processing service benefits and humiliation in front of colleagues, all allegedly rooted in caste bias. However, during the enquiry by the SDPO, Eturnagaram, testimonies from six witnesses did not support the complainant's claims. It was found that the alleged caste-based slurs and abuse were not witnessed by others, the handling of the petitioner's files was procedural and his deputation was an administrative decision. One witness, Smt. Laxmi could not be examined due to ill health. As no evidence supported the allegations, the enquiry concluded that the complaint was baseless and motivated and no case under the SC/ST (Prevention of Atrocities) Act was registered. This letter was sent to the petitioner, vide NCST letter dated 19.01.2025.
- The District Collector, Mulugu vide letter no. C2643/2024 dated 16.01.2025 has informed that an enquiry was conducted into the complaint of Sri A. Thirupathi, Junior Assistant, O/o ITDA, Eturnagaram. A copy of report Project officer, ITDA, Eturnagaram enclosed with the letter. In the report it has been reported that the transfers and deputations were due to administrative exigencies, procedural lapses, and complaints against the employee and were not intended as harassment. Actions such as issuance of memos were also stated to be procedural. In the letter, the report of the Superintendent of Police, Muluqu was also referred. The Collector concluded that the actions taken were strictly on administrative grounds.
- The Commission decided to discuss the issue with the authority and the petitioner on 05.06.2025. Accordingly, a sitting notice was sent on 30.05.2025.

- 6. The District Collector, Mulugu vide letter dated 4.6.2025 has deputed Project Officer, ITDA, Eturnagaram and Superintendent of Police, Mulugu vide letter dated 4.6.2025 has deputed ASP, Eturnagaram to attend the sitting.
- 7. In the sitting, the above officers were present. The petitioner joined via phone. The petitioner has reiterated his earlier submission and requested for justice. The PO, ITDA, Eturnagaram reiterated the facts submitted by the District Collector, Eturnagaram and the ASP, Eturnagaram has also reiterated the facts submitted by SP, Mulugu to NCST. During the discussion the officers has informed that the matter is pending before the Hon'ble High Court of Telangana regarding regularisation of appointment of the petitioner.
- 8. After discussion with the officers of Eturnagaram, District Mulugu, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the minutes.
- The Tribal Welfare Department, Govt. of Telangana may make the list of all employees, who have been transferred during last three years in all ITDAs in the state, available to NCST to examine if any discrimination has happened.

 The petitioner is advised to file the atrocity case in concerned police station, as discussed and suggested by ASP, Eturnagaram in the sitting.
