

**NATIONAL COMMISSION FOR SCHEDULED TRIBES**

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Lokini Sammakka, wife of Ellayya regarding non-issuance of e pattadar passbook.

**Date of the Sitting: 18/06/2025, 02:50 PM**

Smt. Lokini Sammakka, wife of Ellayya, belonging to the Yerukala ST community and residing in Gandhinagar village, Mandal Ghanpur, District Mulugu, has submitted that she has been cultivating agricultural land in Survey Nos. 204/156, 204/80, 204/78, and 204/1/14 for the past 19 years and has been holding Patta Passbook No. 809 for 17 years. Despite applying for the new 'e-Patta Passbook' along with 1-B and Pahani documents and submitting a representation to the Joint Collector, Bhupalpally on 06.07.2020 (which was later forwarded to the Tahsildar, Ghanpur), the new Patta Passbook has not been issued to her. She alleges negligence by the authorities and seeks the Commission's intervention for immediate issuance of the 'e-Patta Passbook' to avail government benefits like Rythu Bandhu and Rythu Bima.

2. NCST vide notice dated 18.02.2025 sought facts and comments from the Collector and DM, Jayashankar Bhupalpally Dist, Telangana within 30 days.

3. The District Collector, Jayashankar Bhupalpally vide his letter dated 26.04.2025 has informed the Commission that Smt. Lokini Sammakka had filed a petition seeking issuance of e-Patta Passbook for land in Survey Nos. 204/156, 204/80, 204/78, and 204/1/14 in Mylaram village, claiming cultivation over Ac.2-30 gts. The Revenue Divisional Officer's enquiry found that the land is classified as government poramboke land, partly assigned to others or covered with hillocks and bushes, and not suitable for cultivation. It was reported that the petitioner had purchased the land through simple sale deeds in violation of the Telangana Assigned Lands (Prohibition of Transfers) Act, 1977, and her name is not recorded as pattadar in official records after 2017-18. The report concluded that the petitioner never possessed or cultivated the land and has no valid claim. The Collector has requested the Commission to dispose of the case accordingly.

4. The Commission decided to discuss the issue with the authority and the petitioner on 18.06.2025. Hence a sitting notice was sent on 10.06.2025.

5. In the sitting, District Collector, Jayashankar Bhupalpally and the petitioner were present.

6. The authority informed that as per the The Revenue Divisional Officer's enquiry it is found that the land is classified as government poramboke land, partly assigned to others or covered with hillocks and bushes, and not suitable for cultivation. It was reported that the petitioner had purchased the land through simple sale deeds in violation of the Telangana Assigned Lands (Prohibition of Transfers) Act, 1977, and her name is not recorded as pattadar in official records after 2017-18.

7. The petitioner has informed that she has the documentary evidences of her posession since past 19 years and its the only source of her livelihood and has given the land to her daughter as a marital gift. Detaching her from her land would result in.

8. After discussion with the District Collector, Jayashankar Bhupalpally and the petitioner, the following recommendations were made and action taken report may be submitted to NCST within 30 days of receipt of minutes.

- It may be due to the ignorance of the ST Petitioner that has resulted in the confusion of the ownership.
- As she possesses the old documents though her name was not recorded as pattedar after 2017-18, considering her BPL status and vulnerability ,the Revenue authorities may examine the feasibility and assign the vacant poramboke/Government land to the petitioner.
