

Minutes of the Hearing held under the Chairmanship of Dr Asha Lakra, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, In the case of Shri Skand Kumar (Architectural Assistant) HUPW, East Zone, 8th Floor, VikasMinar, IP Estate, New Delhi-110002 regarding Discrimination and victimization in promotion of Sh. Skand Kumar a Scheduled Tribe Candidate despite being eligible and falling in zone of consideration from Architectural Assistant (Group 'B') to Assistant Director (Architecture)/AD, Arch) (group 'A') in recent DPC held by Delhi Development Authority (DDA) w.r.t. Establishment Order No. 818, dated 31.12.2024

Shri Skand Kumar, Architectural Assistant, HUPW, East Zone, Vikas Minar, I.P. Estate, New Delhi, vide his letter/email dated 06.01.2025, has submitted a complaint to the Commission alleging discrimination and victimization in the promotion of a Scheduled Tribe candidate, despite his eligibility and inclusion in the zone of consideration for promotion from Architectural Assistant (Group 'B') to Assistant Director (Architecture) [Group 'A'], in the recent DPC held by the Delhi Development Authority (DDA), with reference to Establishment Order No. 818 dated 31.12.2024. Shri Kumar has further requested that the vacant ST seat be allocated to an eligible ST candidate in adherence to the reservation policy, and that the alleged discriminatory practices in DDA's promotion process be investigated.



In this regard, the Commission issued a notice dated 31.01.2025 to Shri 2. Vijay Kumar Singh, Vice Chairman, Delhi Development Authority (DDA),

seeking a detailed report.

In response, DDA submitted a report dated 11.03.2025, in reference to the Commission's notice, stating that the DPC held on 06.12.2024 considered 12 candidates and empanelled 4 officers (UR-1, SC-2, ST-1) for the recruitment year 2025, including Shri Skand Kumar under the ST quota. However, as on 01.01.2025, only 3 vacancies were available, and promotions were made accordingly based on inter-se seniority. Shri Kumar, being fourth in the panel, will be promoted against the next available vacancy. The DDA stated that the DPC adhered to reservation norms and that there was no violation or denial of opportunity in his case.

Subsequently, a rejoinder has been received from Shri Skand Kumar, wherein he reiterates his request for the Commission's intervention, citing that the ST vacancy-lying unfilled since 2023-has still not been allotted to an eligible ST candidate despite his empanelment. He has urged the Commission to ensure the allocation of the said ST vacancy in accordance with the reservation policy, investigate the alleged discriminatory practices in the DDA's promotion process, and ensure compliance with the DoPT OM No. 36012/2/96-Estt.(Res) dated 2nd July 1997 regarding the maintenance of the Roster Register. He has also requested that the DDA be directed to make all reservation-related documents, such as the roster register and Circular 16, publicly accessible to uphold transparency and fairness in the implementation of the reservation policy.

Following the receipt of the rejoinder, the Commission issued a summons 5. to the Vice Chairman, Delhi Development Authority (DDA), for a personal hearing before the Commission to examine the matter further.

The Commissioner (Personnel), Delhi Development Authority (DDA), appeared on behalf of the Vice Chairman, DDA. The petitioner was also present during the hearing.

> After hearing both parties, the Commission recommends the following:

1. The Commission directs the concerned authorities to furnish the following documents:

- (A) The seniority list Arch Assistant (Group B) along with the extended zone of consideration.
- (B) Details of the sanctioned strength of Assistant Director (Arch)
   and the existing seniority list, to be submitted within one week.
- (C) A copy of the promotion order(s) issued subsequent to the promotion of Mr. O.P. Meena.
- 2. As submitted by the concerned authorities during the hearing, the petitioner is expected to be promoted next month upon the retirement of an existing employee. The promotion should be carried out as per applicable rules. The Commission will further examine the matter to determine the date from which the petitioner was eligible for such promotion.
- Accordingly, the concerned department is directed to submit an Action
   Taken Report (ATR) within one month from the date of issuance of these
   recommendations.
