Whereas a Petition/ complaint/ information has been received by National Commission for Scheduled Tribes from Shri Ajeet Kumar Tirkey dated 15/05/2025 as enclosed and the Commission has decided to investigate/inquire into the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India. You are hereby requested to submit the facts and information on the action taken on the said allegations/matters to the undersigned within 15 day(s) of receipt of this notice either by post or in person or by any other means of communication.

Please take notice that in case the Commission does not receive reply from you within the stipulated time, the Commission may exercise the powers of Civil Courts conferred on it under of Article 338A of the Constitution of India and issue summons for your appearance in person or by a representative before the Commission.

Sub:- Regarding Mental & Physical torture by Principal Chief Commercial Manager (PCCM)/South Eastern Railway(S.E.R)- Shri. Upinder Singh.

Respected Sir / Ma'am,

With due respect I beg to state that I Ajeet Kumar Tirkey s/o Late George Elias Tirkey, Village- Sirom Toli, Chutia,Ranchi, Jharkhand -01, belongs to ST (oraon) community and is a resident of Ranchi/Jharkhand.

Presently I am posted at S.E.R as Dy.Chief Commercial Manager (Dy.CCM)/Claims & Refunds/S.E.R from February 2022. Previously, I was posted at ECR/Zone, Hazipur and I have been transferred from ECR in the year 2019 to SER on my own transfer request.. After that, from July 2019, I have worked in SER as DCM/KGP, Sr.DCM(G)/KGP, Dy.CCM/Special, Dy.CCM/System and Dy.CCM/Claims & Refunds within 5 years till now.

As per Railway Board Order No. E(O)111-2025/TR/206 dt. 17.04.2025, I have been transferred to Metro Railway but due to my personal reasons, I have applied to MOBD-Member(Operations and Business Development)/Railway Board/NDLS for my retention at S.E.R on dt. 24.04.2025.

In this context, I want to bring some facts in your kind attention for your kind justice and necessary action:-

- a) After sending an application to MOBD/RB/NDLS through email, I personally met with MOBD Sir on dt. 02.05.2025 and handed over my application to him in his chamber and after favourable assurance and response, I returned back to my HQ/S.E.R on 03.05.2025.
- b) There was my Ticket Checking duty at MURI on 05.05.2025, so I proceeded for Ticket Checking on dt 04.05.2025 and after Ticket Checking at MURI/RNC, I returned back to HQ/S.E.R on dt. 06.05.2025.
- c) On dt. 06.05.2025, I visited BNR Hospital for a medical check up and Dr. Yadav(ACHD/CH/GRC) has advised me to take rest, necessary for my health recovery.
- d) In the meantime, PCCM has released an Order dt. 05.05.2025 sparing me from S.E.R to Metro Railway as per Office Order No. G/26/1328/HQ.Officers/2025 dt. 05.05.2025 without my prior knowledge on his own bias.
- e) On dt. 06.05.2025 PCCM Sir called me on my CUG mobile number (90020 80955) and humiliated, disgraced and threatened me- to which I have evidence supporting this claim recorded (voice) in my mobile phone.

- f) Sir/Ma'am , For your kind information, neither I have relinquished my charge to any one nor I have surrendered my Metal Pass.
 - g) Prejudicially, PCCM Sir & Dy.CCM/PS (Arjun Mazumdar) stopped/terminated the job of my TADK/Bungalow peon on dt. 05.05.2025 although I have not relinquished the charge of Dy. CCM/Claims & Refunds till now from S.E. Railway.
 - h) By putting pressure over Shree Kumar(Medical Director) and Dr. Y.K.Yadav(ACHD/PSY/GRC)-as stated by them, PCCM forced them to declare me fit irrespective of my health concerns, so that I may be released from S.E.R and be forced to join Metro Railway.
 - i) Me, suffering from medical conditions like Blood pressure, Sugar and Cholesterol problems for the past 20 years , which makes it pivotal for my healthy life to undergo regular medical health check ups from time to time and the very act by PCCM of humiliating, disgracing and threatening me over the phone call and forcing me to quit my post has pushed me in a state of Depression , further aggravating my psychological and biological medical concerns.
 - j) Being coming from a Scheduled Tribe community , the Treatment/Behaviour towards me by him(PCCM) has made me to believe that i have been marginalised and been judged upon **not** on the basis of my performance (in office) rather, solely on the basis of belonging to a tribal community.
 - k) And with respect to the prevailing situations and forthcoming circumstances , PCCM being the Principal Head of the Department (PHOD) and me working under him, has made me to worry and be concerned about my Annual confidential report (APAR) being **tarnished** by him which will affect my professional as well as personal life (Retirement,etc).


Lastly, I would like to inform you that with respect to the above mentioned events I have submitted a formal application to G.M/S.E.R - Shri Anil Mishra to take necessary actions against PCCM and DY.CCM (PS) , but I have not received any assurances regarding the same.

In view of the above mentioned circumstances, I pray for your kind justice and to take necessary actions required against them, Please!
