References to above, this is to bring to your kind notice that Sri Suraj Mohali having age less than 25 years applied to the CLW Administration for sanctioning family pension of his deceased mother late Parwati Mohali, who was an employee of CLW. After death of his mother on 07/03/2014, he applied for family pension of the portion of his deceased mother. But the entity of Suraj Mohali has been declined by CLW Administration vide letter under reference (ii) above stating that as you are enjoying family pension of your late father, you are not eligible for family pension of your mother as two family pensions cannot be granted at a time. (photo copy attached)

His father late Opinda Mohali was also an employee of CLW and one family pension of his late father was sanctioned in favour of his deceased mother after her's death. After demise of his mother, portion of family pension of his late father was already sanctioned in favour of him vide PPO No - CLW/2004/0602 w.e.f. 03.2014 to 31.12.2015 and further 01.01.2016 to 14.03.2026.

Railway Board already issued cleared guidelines for sanctioning dual Family pensions (reference - i above) wherein it is mentioned that in the event of death of the parents surviving Child/Children shall be granted the two family pensions subject to certain limits (Copy of the Railway board order attached). The applicant is below 25 years of age and family pension of his father is too meager, therefore it is very difficult for him to run the family with scanty pension amount.

You are, therefore, requested to kindly intervene into the matter to settle the case for investigation and enquiry so that the applicant belong to ST community can get due justice and pension of his mother may kindly be granted to him in pursuant to Railway Board's order attached herewith.
