Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Kurla Raja Reddy, resident of Nimmalagudem village, Buttayagudem Mandal, Eluru Districtregarding cancellation of illegal registrations and licenses.

Shri Kurla Raja Reddy, resident of Nimmalagudem village, Buttayagudem Mandal, Eluru District belonging to ST (Kondareddy) community vide his petition dated 11-10-2024 has alleged that certain individuals, namely Muddu Prasad Rao, and Bidikonda Anjibabu's father Narasimha Rao, acting as benamis of one Tellam Venkata Lakshmi, have illegally constructed baron buildings on village waste land by falsely registering it in the revenue records and obtaining baron licenses in violation of agency area laws. The petitioner alleges that these constructions are endangering the health of the villagers and that repeated complaints to the police and revenue authorities have been ignored due to negligence and corruption. He seeks cancellation of the illegal registrations and licenses, action against the concerned officials, and requests that the land be allotted to landless persons in the village.

- 2. The Commission issued notice to the Collector and District Magistrate, Eluru on 04.04.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received from the authority, hence, the NCST has decided to discuss the issue with the authority and the petitioner on 09.07.2025. Accordingly, a Sitting Notice was sent on 27.06.2025. The Collector and District Magistrate, Eluru vide letter dated 5.7.2025 has sought exemption and deputed Project Officer, ITDA, K.R. Puram, Eluru District.
- 3. In the sitting, the Project Officer, ITDA, K.R. Puram, Eluru District was present but the petitioner was absent. The PO, ITDA has provided the letter no. e-80581/2024/F2 dated 5.7.2025 of District Eluru. In the letter, facts and comments were mentioned and informed that ejectment orders were issued against the said non tribal Sri Bittikonda Anjibabu and instructed the Tahsildar to take possession of subject land and to assign to eligible landless poor STs. The grievance of the petitioner has been resolved.
- 4. After discussion with the Project Officer, ITDA, K.R. Puram, Eluru District, it was observed that grievance of the petitioner has been resolved, hence, there is no action warranted on part of NCST.
