Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Kojja Venkateswarlu regarding police protection for his life and access to his land

Shri Kojja Venkateswarlu, resident of Hanuman Nagar, 3rd Line, Guntur, belonging to ST - Yerukula community, has stated that he purchased 4.20 cents of land in Sy. Nos. 1227, 1227/1 of Sangadigunta, Guntur district from one KattaSrinivasa Rao in 2010 and has been cultivating it since then. When certain disputes arose, he filed a suit in the 3rd Junior Civil Judge Court, Guntur, and obtained a decree followed by a petition for police aid (EP No. 245/2023) which was also allowed. However, despite the court order, Lalapet Police failed to provide protection. Instead, the petitioner alleges that CI Shivaprasad of Lalapet PS supported the other party, used caste-based abuse against him, and ignored directions issued by the SP, Guntur, who had ordered the East DSP to look into the matter. On 12-01-2025, the petitioner's fencing was allegedly destroyed by Kumbha Adinarayana, his sons Vinod, Arjun Rao, Murali, and rowdysheeter Ambedkar along with others, who also threatened to kill him if he returned to the land. The petitioner seeks immediate police protection for his life and access to his land.

- 2. NCST issued notice to the District Collector & Magistrate, Guntur and Superintendent of Police, Guntur vide NCST letter dated 03.04.2025 seeking facts and comments within 30 days from receipt of Notice. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 09.07.2025. Accordingly, a Sitting Notice was sent on 27.06.2025.
- 3. The Superintend of Police and District Collector Magistrate, Guntur have sought exemption and deputed Sub Divisional Police Officer, Guntur and Executive Director, SC Corporation respectively to attend the sitting.
- 4. In the sitting, the Sub Divisional Police Officer, Guntur and the Executive Director, SC Corporation, Guntur were present and the petitioner joined via phone. The Sub Divisional Police Officer, Guntur provides the letter no. 17/C/SC-ST Petns/DCRB/GTR/2025 dated 4.7.2025 of the SP, Guntur. The Executive Director, SC Corporation, Guntur provides the letter no. REVGNT-CSEC0MIS (MISC)/40/2025-JA (C3)-COLGNT dated 7.7.2025 of Collector & District Magistrate, Guntur. In these letters it has been mentioned that the petitioner has no right over the said land. It was also informed that the petitioner and opponent belongs to ST category.

5. After discussion with the Sub Divisional Police Officer, Guntur, the Executive Director, SC Corporation, Guntur and petitioner, it was observed that the petitioner and opponent belongs to ST category, hence, there is no action warranted on part of NCST.
