

NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Pola Sankar, S/o Venkata Swamy, R/o Housing Board Colony, Nandyala, Andhra Pradesh regarding harassment and caste based abuse.

Shri Pola Sankar, S/o Venkata Swamy, R/o Housing Board Colony, Nandyala, Andhra Pradesh, vide his petition dated 27-01-2025 and alleged that he had lodged a complaint on 28-12-2023 at Patamata Police Station against D. Chandrasekhar, General Manager (P&A), Andhra Pradesh State Warehousing Corporation under IPC Section 506 and Sections 3(1)(r)(s) of SC/ST POA Act for caste-based abuse and harassment. However, the FIR No. 714/2024 was registered only on 19-09-2024, after repeated follow-ups. Despite his statements and witness testimonies being recorded, and over four months passing since registration, the investigating officer, ACP Sri K. Damodar Rao has neither filed a charge sheet nor arrested the accused. Shri Sankar alleges deliberate delay due to the accused's influence and further claims that his phone calls to the ACP are now being ignored. He requests to direct the concerned authorities to expedite the filing of the charge sheet and take necessary action against D. Chandrasekhar.

2. The Commission issued notice to the Commissioner of Police, NTR District on 07.04.2025 seeking facts and comments within 30 days.

3. The Commissioner of Police, NTR Commissionerate, Vijayawada vide his letter dated 17-05-2025 has informed that a detailed investigation was conducted by the Assistant Commissioner of Police, Central Division. The ACP recorded statements of 11 witnesses, verified caste certificates, analyzed Call Detail Records (CDRs), and examined documentary evidence such as the visitor register. The investigation revealed inconsistencies in the complainant's allegations, absence of corroborating evidence, and contradictions in witness statements, with some key witnesses found absent from the scene on the alleged date. The inquiry concluded that the essential ingredients under IPC and SC/ST (PoA) Act were not satisfied. Accordingly, the case was referred as "False" vide proceedings dated 22-02-2025, and a Final Report was filed before the Hon'ble III Additional District and Sessions Judge-cum-Special Judge for SC/ST (PoA) Act Cases, Vijayawada, on 21-03-2025. The petitioner was duly informed on 13-03-2025, and no further action is deemed necessary. The Commissioner has requested that the petition be closed. This was sent to the petitioner vide NCST letter dated 03.06.2025.

4. The Commission has decided to discuss the issue with the authority and the petitioner on 10.07.2025. Accordingly, a Sitting Notice was sent on 27.06.2025. The DGP, Govt. of Andhra Pradesh vide letter dated 9.7.2025 has sought exemption for personal appearance of Commissioner of Police NTR, Vijayawada and deputed Dy. Commissioner of Police (Admin), NTR Commissionerate, Vijayawada.

5. In the sitting, Dy. Commissioner of Police (Admin), NTR Commissionerate, Vijayawada was present and the petitioner was absent. The Dy. Commissioner of Police (Admin), NTR Commissionerate, Vijayawada has provided a letter bearing no. 4518/C3/2025 dated 09.7.2025 of Commissioner of Police, NTR Commissionerate, Vijayawada, which contains the facts and comments on the various complaints filed by petitioner in the case. The officer has also reiterated the facts submitted by the Commissioner of Police, NTR Commissionerate, Vijayawada vide his letter dated 17-05-2025 and stated that allegations raised by the petitioner are found to be false.

6. After discussion with the Dy. Commissioner of Police (Admin), NTR Commissionerate, Vijayawada, it was observed that there is no action warranted on part of NCST in the case.
