

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Smt. G.Manga, W/o Late Gogulothu Ravi, Ex-Technical officer, National Geophysical Research Institute (NGRI), Hyderabad regarding denial of compassionate appointment.

Smt. G. Manga, vide her representation dated 08 October 2024, has requested for compassionate appointment to a regular post at the National Geophysical Research Institute (NGRI), Hyderabad, following the death of her husband, Shri Gugulothu Ravi, on 18.05.2021 due to COVID-19. She stated that her husband was employed as a Technical Officer at NGRI and despite several requests to the institute, she has not been provided with a regular appointment. She highlighted severe financial difficulties in supporting her family of six, including three children and aged in-laws, as well as medical expenses for her paralyzed uncle and ailing aunt with kidney failure. She emphasized that a regular job would help sustain her family's needs.

2. CSIR-NGRI vide letter dated 10.1.2025 has informed that the matter will be placed before the compassionate appointment committee in the month of Jan, 2025 to consider her case along with other pending application. The decision of the committee will be intimated as soon as the process is completed. This reply was forwarded to the petitioner on 15.01.2025 for information.

3. In the sitting held on 04.03.2025, the Commission recommended—
“After discussion with the Director, CSIR-NGRI, Hyderabad and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 45 days from the date of sitting.

- The NGRI may expedite the process of pending survey and complete it in 45 days for consideration of the case of petitioner for compassionate appointment.”

4. ATR has not been received. Since there was no progress in the matter, hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 18.07.2025. Accordingly, a Sitting Notice was sent on 14.07.2025.

5. Director, NGRI, COA and M.D, A.O has attended the sitting from the authorities' side and the petitioner has also attended the sitting.

6. The authorities have informed that the delay happened due to the transfer and change of the officials dealing with the administrative matters and compassionate appointments and the process has reached the final stage. The petitioner reiterated that in the earlier hearing held in March 2025, it was recommended that she should be given the compassionate appointment within 45 days.

7. After hearing both the parties the Commission recommends the following -

a. The process may be expedited and the petitioner may be given the compassionate appointment within 30 days as assured by the Director, NGRI and COA, NGRI.

The ATR may be submitted within 30 days from the receipt of the Minutes.
