

National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Shri Rathalavath Munna regarding illegally grabbing of his land by a private company named Aliens Group.

Date of the Sitting: 18/07/2025, 05:00 PM

Shri Rathalavath Munna, resident of Balaji Nagar, Balapur, District Ranga Reddy, Telangana, vide his petition dated 05.04.2025, has alleged that a private company named Aliens Group, owned by Harish Challa and Venkata Challa, has illegally grabbed his land measuring 5 Acres 7 Guntalu situated in Channaram Village, Adavelli Gram Panchayat, Kandukur Mandal, Ranga Reddy District, Telangana. He has further alleged continuous harassment and threats by the company's representatives. He has requested the Commission to take immediate steps to evict the encroachers, restore his land possession, initiate legal action against the accused, and provide protection to him and his family. The petitioner has also submitted land records, including Passbook No. T0526 BH0070317 and Katha No. 60149, as supporting documents.

2. The Commission issued notice to the Collector & District Magistrate, Ranga Reddy vide NCST letter dated 30.05.2025 seeking facts and comments within 30 days.

3. The Collector & District Magistrate vide letter dated 20.06.2025 has forwarded the representation to the Revenue Divisional Officer with a request to enquire into the matter of alleged land grabbing and harassment of an ST individual and submit an action taken report by 28.06.2025 for onward transmission to the National Commission for Scheduled Tribes. A copy has also been submitted to the Research Officer, NCST, and marked to the Tahsildar for a compliance report. But no final report was received.

4. The Commission decided to discuss the issue with the authority and the petitioner on 18.07.2025. Accordingly, a Sitting Notice was sent on 14.07.2025. The RDO, Kandukur, and Tahsildar (I/c) attended on behalf of the authority, and Dr. Kalyan Naik, a relative of the petitioner, attended on behalf of the petitioner.



5. The authority produced an affidavit of Shri Rathalavath Munna dated 27.06.2025, wherein he submitted, in the presence of panchas and witnesses, that he has no disputes with Aliens Developers Pvt. Ltd. and has withdrawn the complaint filed before NCST.

6. Hence, no further action by NCST is warranted. However, the authority is advised to ascertain whether the petitioner withdrew the petition willfully or under coercion.
