With due respect and humble submission, this Association would like to put forth the grievance of Shri Hemlal Tudu son of Late Budilal Tudu, Ex. T/No-16/584 & Control No-325104, CLW/Chittaranjan (Indian Railway), Address: Village-Namokesia, PO- Achhra, PS-Salanpur, Distt.-Paschim Bardhaman who belongs to ST community. It is pertinent to mention that after death of Late Bodilal Tudu, his son Shri Hemlal Tudu appealed to CLW Administration for employment under CGA in support of required documents with the help of someone after being fallen into trap of false persuasion due to ignorance and less education wherein the educational certificate was not at par with. Accordingly the case of his employment process was regretted by the CLW Administration.

Thereafter, he acquired the standard educational qualification (Class X passed) and re-appealed for re-consideration for employment but again his case was regretted. As such now he is facing severe financial hardship and leading a down to earth miserable life.
