Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri V. Sairam, Income Tax Inspector, Hyderabad regarding harassment and assault by police officials.

Shri V. Sairam, Income Tax Inspector, Hyderabad vide his representation dated NIL has alleged that his wife Swetha Rani and her family falsely represented themselves as belonging to the Scheduled Tribe, Bentho-Oriya, and married him with an ulterior motive targeting his government job and salary. He detailed instances of mental harassment, caste-based abuses using derogatory terms against him his family, theft of cash and gold worth Rs. 12 lakhs and 30 tolas respectively, and false police complaints against him and his family. He further stated that police officials from Atmakuru, Nellore, colluded with his wife's family, assaulted him, forced him to sign on stamped papers under threat of arrest and job loss and later threatened his family at his residence in Hyderabad. FIRs have been lodged against his wife and her relatives for theft and misrepresentation of caste for marriage registration. He requested the Commission to direct the authorities in Andhra Pradesh to take strict action, including suspension of the concerned police officials for their high-handed behavior.

- 2. The Commission issued notice to the DGP, Government of AP and the Superintendent of Police, Nellore on 04.04.2025 seeking facts and comments within 30 days from receipt of the Notice (It is pertinent to mentioned that the petitioner father has also filed the same issue, which is also discussed in the sitting on 9.7.2025)
- 3. Superintendent of Police, SPS Nellore District, vide letter no. 2717/C3/2025 dated 17.05.2025 has informed that an enquiry was conducted on the representation of Shri V. Sairam, Income Tax Inspector, who alleged collusion between Atmakur Police officials and his wife Swetha Rani. The enquiry revealed that two criminal cases—Cr.No.18/2024 under Sections 498(A) IPC & 3, 4 D.P. Act and Cr.No.153/2024—are registered against V. Sairam and his family members in Atmakur Police Station, with one charge sheet filed and another under investigation. Additionally, cases registered in Chaitanyapuri Police Station, Telangana on the petitioner's complaint against his wife and her family, which are under investigation by local jurisdiction. The report stated that allegations of harassment and manhandling by police are unsubstantiated as counseling was held in the presence of stakeholders before case registration. The petitioner was advised to lodge complaints regarding alleged caste abuse with the concerned jurisdictional police in Hyderabad. This was sent to petitioner on 3.6.2025 for satisfaction.
- 4. The petitioner vide rejoinder dated 17.06.2025 has refuted the facts and comments and requested for justice. Hence, the NCST decided to discuss the issue with the authority and the petitioner on 9.07.2025. Accordingly, a Sitting Notice was sent to all concerned on 27.06.2025.
- 5. The DGP, Govt. of Andhra Pradesh vide letter no. 4113/C2/NCST/ 2025 dated 3.7.2025 has deputed the Superintend of Police, SPSR to attend the sitting.
- 6. In the sitting, the Superintendent of Police, SPSR, Nellore District and petitioners were present. The petitioners reiterated their submission and requested for justice. The SP, Nellore District has reiterated the facts submitted by them to NCST. It was also informed that the matter is pending before the Hon'ble JMFC, Atmakur vide CC No. 374/2024.

7. After discussion with the Superintendent of Police, SPSR, Nellore District and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.

- The petitioner is advised to submit all the corroborative evidences of he being manhandled by police and admitted to the Hospital or under treatment.
- The police may enquire into the community status of both and know the facts on who hid their community from each other with vested interests of cheating each other. A detailed report may be submitted.
- Counseling may be facilitated by Police in case of such marital disputes especially when the children are born to the couple and their psycho-social development is affected by the quarrels between the Husband and wife.
- The petitioner is advised to file the case against the opponent under PoA Act in the local Police Station of the jurisdiction where the incident has happened.
- The petitioner and petitioners family is advised not to lodge multiple complaints on the same issue in NCST to save valuable court time of NCST.
