Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at New Delhi in the case of Sri Chandavath Suman, Gundenga Village, Gudur Mandal, District - Mahabubabad regarding non release of subsidy by Telangana Grameena Bank.

Sri Chandavath Suman of Gundenga Village, Gudur Mandal, District - Mahabubabad has submitted a representation dated 24.01.2025 stating that he was sanctioned a subsidy amount of ₹80,000 for the year 2021–22. However, despite having made a fixed deposit of ₹23,000 as required, the Telangana Grameena Bank has not released the sanctioned subsidy. He has requested intervention to ensure for release of the pending subsidy amount.

- 2. NCST issued notice to the Chairman, Telangana Grammeen Bank on 16.05.2025 seeking facts and comments within 30 days from receipt of the Notice.
- 3. The reply was not received, hence, NCST decided to discuss the issue with the authority and the petitioner on 09.07.2025. Accordingly, a Sitting Notice was sent to all concerned on 27.06.2025.
- 4. The Chairman, Telangana Grammeen Bank vide email dated 7.7.2025 has sought exemption and deputed General Manager (HR) to attend the sitting.
- 5. The General Manager (HR) was present but the petitioner was absent. The GM (HR) has informed about the credibility in favour of the petitioner. The CIBIL Score of the petitioner is not good.
- After discussion with the authority, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.
- The overdues of Rs,34,450 may be paid immediately by the petitioner to claim the subsidy amount.
