Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi in the case of Sri Ashok Rathod, State President of the Girijana Sangala Joint Action Committee regarding derogatory remarks against STs by actor Vijay Deverakonda.

Sri Ashok Rathod, State President of the Girijana Sangala Joint Action Committee (GAC), Singareni Colony, Saidabad, Hyderabad vide representation dated 03.05.2025 has informed the Commission that during the pre-release event of the film Retro, actor Vijay Deverakonda made derogatory remarks which insulted and hurt the sentiments of the Scheduled Tribe communities. The remarks, including statements about "people fighting without common sense" and comparisons implying links to terrorists, were widely broadcast on media platforms and allegedly violate provisions of the SC/ST (Prevention of Atrocities) Act, 1989. He has enclosed a video link as evidence and requested the Commission to take cognizance, direct authorities to register an atrocity case, and recommend legal and disciplinary action to protect the dignity and rights of Scheduled Tribe citizens.

- 2. NCST vide Notice dated 16.5.2025 has referred the matter to the Commissioner of Police, Hyderabad for furnishing the facts and comments within 15 days from receipt of the notice.
- 3. The reply was not received, hence, NCST has decided to discuss the matter with the concerned authority and petitioner on 9.7.2025. Accordingly, a sitting notice was issued to all concerned on 1.7.2025.
- 4. The Commissioner of Police, Cyberabad vide communication dated July, 2025 has sought exemption and deputed ACP Madhupur Division to attend the sitting.
- 5. In the sitting, ACP, Madhupur Division and petitioner were present. The petitioner reiterated his earlier submission and requested for justice. The ACP, Madhupur Division has informed that the opponent has filed the case before the Hon'ble High Court of Telangana against the FIR filed by the petitioners.
- After discussion with the ACP, Madhupur Division and petitioner, the following recommendations
 were made and action taken there on may be submitted to NCST within 30 days from receipt of the
 Minutes.
- As the celebrity has clarified that he had "absolutely no intention to hurt or target any community", and expressed his regrets over alleged comments, no further action is warranted on part of NCST.

 Further it is adviced that the Police may counsel the celebrities to speak with caution and responsibility as they are being watched on live media and it will go viral in seconds.
