Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Ram Dev Mandal, Assistant Manager (Tech-Electrical), Project Management Cell, Reserve Bank of Indiaregarding transfer from Delhi to Patna or Ranchi.

Shri Ram Dev Mandal, Assistant Manager (Tech-Electrical), Project Management Cell, Reserve Bank of India, New Delhi, vide his petition (undated) has alleged that he, a member of the Scheduled Tribe (Kharwar), is being repeatedly harassed by the bank administration, including forced transfer from Patna to Delhi despite his wife's serious spinal ailment and his own recent heart-related health issues exacerbated by Delhi's pollution. He claims that his transfer was initiated due to his refusal to pay illegal commission demanded by a senior officer, Rahul Sinha, and that he has been targeted with baseless allegations and disciplinary warnings ever since. He also states that despite submitting multiple representations requesting transfer to Ranchi for medical reasons and attaching supporting documents, no response was provided. He requests the Commission to intervene and issue directions to transfer him to the RBI office in Ranchi on humanitarian and medical grounds.

The Commission issued notice to the ED, Reserve Bank of India, Mumbai on 17.03.2025 for furnishing the facts and comments within 30 days from receipt of the Notice. The Assistant General Manager, Reserve Bank of India, New Delhi vide letter no. DEL.HRMD.ADM.No.S419/04-01-002/2025-26 dated 30.04.2025 has informed that the allegations of harassment, false accusations, threats of dismissal, and corruption levelled by Shri Ram Deo Mandal are false, baseless, and devoid of merit. It has been submitted that the petitioner had earlier filed similar complaints which were found unsubstantiated and his retirement review was deferred due to low KRA scores, adverse remarks, and pending vigilance matters. The Bank stated that his transfer to New Delhi was based on the Annual Transfer Programme and in compliance with Central Vigilance guidelines. It was also clarified that the transfer was not influenced by any individual officer and that Shri Mandal had previously requested transfers which were granted. The complaint by his wife and threats made therein were taken seriously and the petitioner was advised to seek police and psychological support. The Bank further stated that the petitioner's claims of wrongful action and victimization were examined by an internal committee, which found no substance in them and his integrity is under review due to vigilance concerns. His request for transfer to Ranchi is under consideration subject to administrative exigencies. This reply was communicated to petitioner for information. The petitioner refuted the facts and requested for justice.

3. Hence, NCST decided to discuss the issue with the authority and the petitioner on 17.06.2025. But the discussion could not held as the concerned officers were not present. The petitioner was present. Therefore, NCST has refixed the sitting on 11.7.2025. Accordingly, a sitting notice was issued on 1.7.2025 to all concerned.

4. In the sitting, CGM (HRMD), RBI, Mumbai and CGM, RBI, New Delhi alongwith other Sr. officers were present in the sitting. The petitioner was also present. The petitioner reiterated his earlier submission and requested to transfer from New Delhi to Ranchi. The officials from RBI reiterated their earlier submission and stated that the petitioner's request had been considered favourably by the Bank on several occasions and that he was transferred from Patna in accordance with vigilance circulars requiring rotation from sensitive posts after a certain period. The petitioner reiterated that he was in poor health and his wife was also unwell. He emphasized the need to be near his family during this time and mentioned that his retirement was approaching. He, therefore, requested a transfer to either Patna or Ranchi. The Officers of RBI informed that at present there is no post, as per entitlement of the petitioner. Therefore, the request of the petitioner for transfer from Delhi to Ranchi may not be considered.
