## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Laxman Shankreppa Walikar regarding non-payment of compensation.

Shri Laxman Shankreppa Walikar, a resident of Muddebihal, Vijayapura district (Karnataka) has submitted a representation regarding the non-payment of compensation for 9 acres 39 guntas of ancestral land acquired by the Government of Karnataka in 1959, and additional encroachment of 1 acre 3 guntas handed over to the Chairman of the Muddebihal Housing Society. Despite not receiving any compensation or relief, the Karnataka High Court ordered him to pay a certain amount, adding to his distress. He has requested for justice and rightful compensation.

- 2. The Commission issued notice to the Deputy Commissioner, Vijayapura and Commissioner, Deptt. of Land Survey, Revenue Settlement and Land Records on 23.01.2025 seeking facts and comments within 30 days from receipt of the Notice.
- 3. Deputy Commissioner, Vijayapura District, vide letter no. RB/LAQ/E-Office-199772/2023-24 dated 13.02.2025 has informed that land measuring 9 acres 39 guntas in Sy. No. 98 of Muddebihal town was acquired in 1965 on request of the Agriculture Produce Market Committee, Talikoti and possession was handed over in 1967. As per the award passed on 20.11.1967, since the land was classified as Inam 6(b) and assigned for remuneration to Officiator Walikar, the compensation was credited to the Government. The Deputy Commissioner further stated that the applicant approached the Karnataka High Court in W.P. No. 201060/2024, which directed the concerned authorities to consider his representation. Accordingly, the Agriculture Produce Market Committee issued an endorsement to the applicant. Terming the matter as civil in nature. The Deputy Commissioner has suggested that the applicant may seek remedy from the competent court of law and requested the Commission to dispose of the petition, as the grievance has been raised after nearly 58 years.
- 4. NCST has decided to discuss the issue with the authorities and the petitioner on 11.07.2025. Accordingly, a Sitting Notice was sent on 25.06.2025 to all concerned.
- 5. The Commissioner, Deptt. Of Survey, Settlement and Land Records, Bangalore vide letter dated 10.7.2025 has sought exemption and deputed Sr. officers of the Department of Land Records to attend the sitting. The Dy. Commissioner Vijayapura vide letter dated July, 2025 has deputed Asstt. Commissioner and SDM Vijayapura to attend the sitting.
- 6. In the sitting, the above officers of State Govt. of Karnataka and District Administration of Vijayapura were present. The petitioner was also present. The petitioner reiterated his earlier submission and requested for justice. The officers of D/o Survey, Settlement and Land Records had provided the letter no. SSLR/11036/528/2024 dated 10.7.2025 of Commissioner, D/o Survey, Settlement and Land Records in the sitting. In the letter it has been mentioned that the petitioner has approached the Hon'ble High Court of Karnataka seeking relief in respect of Land Survey no. 98. The Court has disposed of his application. It was also informed that the petitioner is falsely claiming rights over the land in survey no. 98 & 104 without any documentary proof of ownership.

After discussion with the officers of State Govt. of Karnataka and District Administration of Vijayapura and petitioner, it was observed that the petitioner has not provided any documents to the authority in support of his ownership. However, the District Administration, Vijayapura and concerned authorities are advised to re-examine the case for justice to the ST petitioner.
