Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Dilkusha Guest House, Hyderabad in the case of Dr. G. Sridevi regarding declaration of the result for the post of Assistant Professor (ST-Women) in Osmania University.

**Date of the Sitting: 18/07/2025, 01:30 PM**

Dr. G. Sridevi, vide her representation dated 02/07/2024 has requested the Commission to direct Osmania University to declare the result for the post of Assistant Professor (ST-Women) – Backlog in the Department of Education. She has cited multiple High Court orders, including W.P.No. 46576 of 2018 dated 30/07/2019, which directed the University to declare the results. However, the University, instead of complying, cancelled the recruitment notification, citing undeserved marks awarded and notified cancellation via a press release. The petitioner claims this act is discriminatory as other posts under the same 2012 notification have been filled, while the only ST post remains vacant despite availability of qualified candidates. She has also filed W.P.No. 34332 of 2022 challenging the cancellation, which is currently pending. She seeks intervention to revoke the Executive Council's decision dated 30/09/2021 and direct the University to declare the result as per court orders.

2. The Commission issued notice to the Vice Chancellor, Osmania University, Hyderabad vide NCST letter dated 26.04.2025 seeking facts and comments within 30 days.

3. The Commission decided to discuss the issue with the authority and the petitioner on 18.07.2025. Accordingly, a Sitting Notice was issued on 14.07.2025. The authorities, i.e., the Registrar, Osmania University, and the petitioner, Dr. G. Sridevi, attended the sitting. The petitioner reiterated her earlier submissions.

4. The authority, i.e., the Registrar, Osmania University, informed that one ST(W) post of Assistant Professor under SC/ST backlog (unfilled vacancies of Assistant Professors vide Advt. No. 1/2006) was partially re-notified vide Advt. No. 5/2010 dated 06.02.2012 in the Department of Education. Accordingly, 12 candidates who fulfilled the requisite qualifications as per UGC Regulations 2010 dated 30.06.2010 (RSP-2006) were called for the interview conducted on 22.04.2013. Out of these, nine candidates, including Dr. Azmeera Leela, attended the interview. Dr. Azmeera Leela submitted a representation to the Government vide her application dated 08.07.2014, stating that she came to know through media and other sources about the selection of Smt. G. Sridevi as Assistant Professor in the Department of Education (ST-W) and alleged that Smt. Sridevi had submitted a fake experience certificate from UK College of Education, Keesaragutta, and that she was pursuing a full-time Ph.D. while simultaneously working full-time as a project faculty in the Tribal Welfare Department, Government of Andhra Pradesh. While considering this representation, the Government of Telangana, vide their letter No. 846/UE&VC/2014-1 dated 24.07.2014, directed the University to stay the recruitment process for the said post until further orders and to take immediate action.

5. After a series of deliberations, a committee was set up, and a meeting held under the Chairmanship of the Joint Secretary to Government, Higher Education Department, on 04.12.2017 concluded that the teaching experience claimed by G. Sridevi, for which she was awarded 4 marks by the selection committee, was not valid as she was simultaneously working in the TW Department. The committee recommended necessary action. The University obtained legal opinion and placed the matter before the Executive Council for consideration of the Hon'ble High Court's directions. In its 162nd meeting held on 30.09.2021, the Executive Council resolved to cancel the advertisement issued for the ST(W) category in the Department of Education under SC/ST backlog vacancies. It was further resolved to re-notify the vacancy along with other vacancies as and when notified by the University. The same was also communicated to the petitioner vide letter No. MR-10/193/2013/Adm.II-1 dated 10.02.2022.

6. After hearing the authority and the petitioner, the following recommendations are given:

a. From the explanation given by the authority, it appears that the petitioner's claim has no merit. As the grievance is about the cancellation of the notification which has the grounds of the valid reasons of proven allegations made by the opponent of the petitioner and action is taken after legal opinion and approval of EC, no action is warranted on part of NCST.



c. Further, since the petitioner's case, W.P. No. 34332 of 2022, challenging the cancellation, is pending before the Hon'ble High Court of Telangana, the matter may be treated as sub-judice and closed accordingly.
