## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at LokNayakBhawan, New Delhi regarding payment of ex gratia in the case of Smt. V. Dimgohching (W/o Late V. Nangthanlian, Ex- Driver, Trade and Taxes Department, GNCTD).

Smt. V. Dimgohching (W/o Late V. Nangthanlian) New Delhi vide representation dated 12.03.2024 has alleged that her husband (Late V. Nangthanlian, Ex Driver,) expired due to COVID-19 on 01.05.2021 at Lal Bahadur Shastri Hospital, Delhi while on government duty. The concerned department i.e. Death Audit Committee, Department of Health, GNCTD, Delhi is not considering the report of Maulana Azad Medical College for positive report of COVID issued in favor of her husband on 03.05.2021, which was handed over after the death of her husband. She has requested to look in to the matter and to release of Ex- Gratia Amount i.e One Crore Rupees as decided by GNCTD during COVID-19.

- 2. In this matter, sittings were held earlier on 10.09.2024, 09.12.2024 and 27.01.2025. In the last sitting held on 27.01.2025, the following recommendations were made and minutes were forwarded on 13.02.2025 with request to furnish the ATR by 1st March 2025 –"After discussion with the officers of Health & Family Welfare Department, the Trade & Taxes and Revenue Department of GNCTD and petitioner, it was decided that there is no requirement for presence of officials from Trade and Taxes Department and Health and Family Welfare Department of GNCTD in next sitting. The action requires to be taken by Department of Revenue, GNCTD, New Delhi only. It is recommended that the case may be processed expeditiously after formation of new government in UT of Delhi. The action taken in the matter may be submitted to NCST by 1st March, 2025."
- 3. The action taken report was not received from Revenue Department, hence, Revenue Department was reminded on 06.03.2025. The Deputy Commissioner-II (HQ), Revenue Department, GNCTD, vide letter no. F.1(58)/Relief/Ex-gratia/Forwarding/2023/243 dated 19.3.2025 has informed about the chronological events in the matter and stated that the file has been re-submitted to the Hon'ble Minister (Revenue) on 12.03.2025 for final decision regarding the ex-gratia payment. Therefore, to resolve the issue, the NCST has decided to discuss the issue with the authority and the petitioner on 11.07.2025. Accordingly, a Sitting Notice was sent on 25.06.2025.
- 4. In the sitting, officers from concerned Departments of GNCTD and petitioner were present. The petitioner has reiterated her earlier submission and requested to release the ex gratia amount urgently. The officials from Department of Revenue, GNCTD informed that a meeting of GoM was fixed for 7.7.2025 which could not be held due to Administrative reasons, hence, this case would be placed in the next meeting of Group of Ministers for consideration.
- 5. After discussion with the officers of the various Departments of GNCTD and petitioner, it was recommended that the Department of Revenue, GNCTD may ensure that this case may be placed before the next meeting of GoM, as assured in the sitting. An action taken report in this regard may be sent within one month of receipt of minutes.
