## National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Kedar P, District—Dharwad regarding compassionate appointment.

Shri Kedar P, S/o Late Shri Prakash B (Employee of Postal Department of Kolar District) Dharwad-District (Karnataka) vide his representation dated 08.03.2025 has stated that he is the only son of late Shri Prakash B, who served as LSG SPM in Bangarpet, Kolar District, Karnataka and passed away on 07.05.2021 due to COVID-19 during service. He applied for a compensatory job to support his dependent mother and himself but his application was not accepted by the Department of Posts, Karnataka, citing lack of vacancies. Despite applying for two consecutive years, his application was rejected in the third year without legal clarity on whether it was a permanent rejection or subject to future vacancies. He has requested for justice.

- 2. NCST issued notice to Senior Superintendent of Post Offices, Kolar Division on 22.04.2025 for seeking facts and comments within 30 days from receipt of the notice. The reply was not received from the concerned authority, hence, NCST has decided to discuss the issue with the authority and the petitioner on 23.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025.
- 3. In the sitting, Senior Superintendent of Post Offices, Kolar Division and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The SSPO has furnished the facts and comments alongwith supporting documents and stated that the case of petitioner has been considered as per rules. But, the committee has not approved his case.
- 4. After discussion with the officer and petitioner, it was observed that the action taken by the D/o Post in the matter appears to be in order. Hence, no action is warranted on part of NCST and case may be closed.
