Rajaram, Divisional Secretary, Aistravawasa, Trichy Divisional, Tiruchirappalli in matter of -Request for re-instatement in service on mercy and sympathetic manner from the punishment of Compulsory Retirement-revision petition-submission and requisition – letter dated 26.02.2025 of Shri G.Rajaram, Assistant General Secretary, ISTREW Association, Southern Railways, Chennai (Tamilnadu).

- Shri G. Rajaram, Assistant General Secretary, ISTREW Association, Southern Railways, Chennai (Tamil Nadu), vide his letter dated 26th February, 2025, has submitted a representation seeking re-instatement into service on compassionate and sympathetic grounds. He was awarded the penalty of Compulsory Retirement in connection with a disciplinary case involving sub-letting of a Railway Quarter, under Rule No. 15(A) and Rules 3(1)(i) & (iii) of the Conduct Rules, 1966. Shri Rajaram has requested the Commission to direct the Southern Railway administration to reconsider his revision petition in light of his family's circumstances.
- 2. In this regard, a notice was issued to the General Manager, Southern Railway on 13.05.2025, seeking facts and information on action taken. A reply dated 10.06.2025 was received from the Deputy Secretary, Southern Railway, stating that the Disciplinary and Appeal Rules (DAR) case has already been finalized up to the level of the revisionary authority. It was further conveyed that, therefore, no further action can be taken with respect to his reinstatement or reconsideration of the revision petition.
- 3. The reply received was duly forwarded to the petitioner, who subsequently expressed dissatisfaction with the response. In view of this, a sitting was scheduled for 15.07.2025. Accordingly, a summons dated 01.07.2025 was issued to the General Manager, Southern Railway, and the petitioner was informed of the scheduled hearing through NCST letter dated 03.07.2025.

In view of the facts presented and the submissions made by both parties, the
matter stands closed before the Commission at this stage. However, if any new
and substantive material or evidence comes to light in future, the petitioner shall
