- 4. The Principal Secretary, Urban Development & Housing Department (UD&HD), Government of Jharkhand, and the representative of the petitioner were present during the hearing.
- 5. The Principal Secretary submitted during the hearing that due to a lack of budget in the Municipal Corporation, the Municipal Administration will, in the meantime, pay 50% of the amount to the petitioner, and the remaining balance will be paid at a later stage.

After due consideration of the submissions made and hearing the parties concerned, the Commission hereby makes the following recommendations:-

- 1. In light of the submissions made by the Principal Secretary, Urban Development & Housing Department (UD&HD), Government of Jharkhand, the matter may be considered for closure by the Commission.
- 2. The Principal Secretary, Urban Development & Housing Department (UD&HD), Government of Jharkhand, shall submit a detailed status report and latest update to the Commission within 30 days from the issuance of these recommendations.

Shri Pramod Oraon, Junior Engineer in Manjhiaon Nagar Panchayat of Garwha District, Jharkhand, vide his letter/complaint dated 08.11.2024, has submitted regarding non-payment of prolong salary dues/honorarium amounting to . Rs. 9,48,966/- by Manjhiaon Nagar Panchayat of Garwha District, Jharkhand. As per the recruitment terms of the Directorate of Municipal Administration, the concerned urban body was responsible for paying his salary, failing which the Urban Development Department was to ensure payment. Despite serving for a long period, he received only partial salary payments. Due to this, he is facing great hardships. He has requested the Commission to kindly intervene in the matter so that his rightful dues are paid without further delay.

2. The Commission, in its notice dated05.03.2025, referred the matter to the Principal Secretary, Urban Development &Housing Department (UD &HD), Govt. Of Jharkhand, Secretariat, Ranchi for facts and comments.
