### National Commission for Scheduled Tribes

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt. Yamuna N, Chief Engineer(Co-ordination), Bruhat Bangalore Mahanagara Palike regarding unjust transfer.

**NCST/SER-2379/KA/4/2025-RU-III**

**Date of the Sitting: 23/07/2025, 3:40 PM**

**Participants in the Sitting: As per Annexure**

Smt. Yamuna N, Chief Engineer (Co-ordination), Bruhat Bangalore Mahanagara Palike (BBMP) vide her representation dated 23/05/2025, has stated that she was appointed as Assistant Engineer on 28/11/2003 and promoted to Chief Engineer. She alleges that she has been unjustly transferred to a newly created post of Chief Engineer (Co-ordination) under the Engineer-in-Chief (EIC), which functions more as a technical assistant role, despite her seniority and clean service record. She contends that this action was influenced by the EIC, who holds multiple charges and allegedly harbored animosity against her for not complying with his directions in an earlier tender matter. She highlights that other Chief Engineers retain independent charge, but she alone has been placed in a subordinate role, which she claims amounts to discrimination as a Scheduled Tribe woman. Her repeated appeals to the Chief Commissioner have gone unaddressed, leading to mental distress.


2. The Commission issued notice to the Secretary (Urban Development) Govt. Of Karnataka and the Commissioner (BBMP) on 13.06.2025 for seeking facts and comments within 30 days from receipt of the Notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 23.07.2025. Accordingly, a Sitting Notice was sent to all concerned on 16.07.2025.

3. The Dy. Commissioner (Admin) vide letter dated 22.7.2025 has sought exemption and deputed Addl. Resident Commissioner, Karnataka Bhawan, New Delhi to attend the sitting on behalf of Chief Commissioner, BBMP, Bengaluru.

4. In the sitting, the Addl. Resident Commissioner, Karnataka Bhawan, New Delhi was present. The petitioner joined via phone. The petitioner has reiterated her earlier submission and requested for justice. However the authority vide Lr.No:B12(6)/P R/E-138929/25-26 informed that Smt. N. Yamuna, Chief Engineer who was promoted and posted on 15-03-2022 as the Chief Engineer (O.F.C.). Then later she was posted as Chief Engineer (Co-ordination) for the administrative convenience vide office order No.B12(6)PR/152/24-25, dated: 25-03-2025. Presently, she is posted to the position of Chief Engineer (Dasarahalli) vide office order No.B12(6)PR/E-151310/25-26, dated: 17-07-2025. Now, she is currently working as Chief Engineer (Dasarahalli) which has addressed her grievance fully. However the petitioner over phone has informed that she was posted in a sensitive place where she could not execute her expertise due to regular political interference.

5. After discussion with the Addl. Resident Commissioner, Karnataka Bhawan, New Delhi and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from receipt of the minutes.

a. As requested by the Chief Commissioner, Bruhat Bengaluru Mahangara Palike, 04 weeks time is granted to the authority to discuss the matter with the petitioner and to resolve the issue amicably by posting her appropriately as per the rules.
