## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Sarala Tudu, R/o Choruipur, Choto Simulia, PS:Bolpur, Dist:Birbhum, West Begal regarding land related atrocities committed on her by the caste hindus.

Smt. Sarala Tudu, a poor Scheduled Tribe lady and permanent resident of Vill-Choruipur, P.S.-Bolpur, Dist-Birbhum, West Bengal, has submitted a representation dated 24.02.2025 stating that her father, Santi Murmu, was a bargadar of 97 decimals of agricultural land in Mouza-Tatarpur, Dist-Birbhum till his death on 15/10/2010, after which she continued cultivation as his only legal heir. She alleges that one Malay Pit, an influential person, forcibly evicted her from the land in her absence, constructed a boundary wall for his polytechnic college, and changed the land's nature, causing her severe financial hardship. Despite repeated complaints to BL & LRO, DL & LRO, Bolpur P.S., and SC/ST officers regarding her illegal eviction and pressure from police for compromise, no relief has been provided.

- 2. The Commission issued notice to the District Collector, Birbhum and the Superintendent of Police, District Birbhum on 06.03.2025 seeking facts and comments within 30 days.
- 3. Superintendent of Police, Birbhum, vide his letter dated 21.03.2025 has informed the Commission that an enquiry was conducted by Shri Rickey Agarwal, SDPO Bolpur, into the petition of Smt. Sarala Tudu regarding her allegation of illegal eviction from her barga land. It was found that Plot No. 144/162, JL No. 124, Mouza-Tatarpur (measuring 0.97 satak), initially owned by Sarboranjan Roy, was cultivated by her father Santi Murmu as a bargadar. After his death, Sarala Tudu continued cultivation, but the landowner sold the plot to Malay Pit, who constructed a boundary wall and obstructed her cultivation. A case was registered vide Bolpur PS Case No. 289/22 dated 20.09.2022 under Section 506 IPC r/w Section 3(1)(g) of the SC & ST (POA) Act, 1989, which culminated in a charge sheet (CS No. 25/2024 dated 13.02.2024). This was sent to the petitioner vide NCST letter dated 02.07.2025.
- 4. The petitioner has refuted the facts and requested for justice, hence, NCST has decided to discuss the issue with the authority and the petitioner on 25.07.2025. Accordingly, a Sitting Notice was sent on 18.07.2025.
- 5. In the sitting, the Collector & District Magistrate and SP, Birbhum Districts joined through Video Conference and petitioner joined through phone. The petitioner reiterated her submission and requested for justice. The SP and Collector, District Birbhum submitted the facts and stated that a charge sheet was filed vide CS No. 25/2024 dated 13.2.2024. Hence, No action is required on part of District Administration.
- After discussion with the authorities and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the Minutes.
- The petitioner is advised to meet the District Administration (District Collector & Magistrate and SP, Birbhum in next week and present her papers in support of the claim.
- The District Administration (District Collector & Magistrate and SP, Birbhum) are also advised to meet the petitioner for resolving her issues, as assured in the sitting.
