Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Amgoth Dhanraj Nayak, PCR/POA Act Member and District Vigilance & Monitoring Committee Member, Medchal-Malkajgiri District regarding Alleged encroachment and misuse of passage and graveyard land assigned to tribal farmers in Ravalkole Village, Medchal-Malkajgiri, by Grama Panchayat and private real estate interests, affecting access and safety of nearly 40 tribal families.

Shri Amgoth Dhanraj Nayak, PCR/POA Act Member and District Vigilance & Monitoring Committee Member, Medchal-Malkajgiri District, vide his petition dated 01.08.2022, has alleged that around eleven acres of land in Sy.Nos. 747 and 748 at Ravalkole Revenue Village were assigned to tribal farmers, out of which three acres, used as a passage and graveyard, were recently allocated by the District Collector to the Grama Panchayat of Saidonigadda Thanda for public purposes. He claims that this allocation has caused obstruction to nearly 40 tribal farmers who rely on this passage for agricultural access. Further, he alleges collusion between local Panchayat officials and a private real estate company, which is attempting to encroach the passage land for a gated community, involving anti-social elements who are reportedly abusing and harassing tribal farmers, including women. The petitioner requests the Commission to intervene, cancel the allocation order, ensure safety and access to the tribal farmers, and prevent further permissions being granted to the real estate company.

2. The Collector & District Magistrate, Medchal-Malkajgiri vide letter dated 4.4.2025 has furnished the action taken report and stated that the matter is pending before the Hon'ble High Court of Telangana in WP No. 19976 of 2024.

3. In the sitting held on 15.05.2025 whose minutes were sent on 10.06.2025 – “7. After hearing both the sides, the Commission recommends the following and action taken report to be submitted within 60 days –

- The DTCP may be addressed by the District Collector as to how the lay out permission is given when the Government land is encroached.
- A comprehensive report may be submitted in 60 days”

4. As the action taken report was not received, the Commission decided to discuss the issue with the authority and the petitioner on 25.07.2025. Accordingly, a Sitting Notice was issued on 18.07.2025. The District Collector, Medchal-Malkajgiri, attended the hearing in person, while the petitioner, Shri Amgoth Dhanraj Nayak, joined over phone.

5. The petitioner reiterated that approximately eleven acres of land in Sy.Nos. 747 and 748 of Ravalkole Revenue Village were assigned to ST farmers, out of which around three acres—used as a passage and graveyard—were allocated by the District Collector to the Grama Panchayat of Saidonigadda Thanda for public purposes. He emphasized that this allocation obstructs nearly 40 ST families from accessing their agricultural lands. He further alleged ongoing collusion between Panchayat officials and a private real estate company aiming to encroach on the passage land for a gated community, with the involvement of anti-social elements reportedly harassing and abusing ST farmers, including women.

6. The District Collector informed that the vacate petition is yet to come up before the bench and that a counter will be filed shortly. It was also stated that the DTCP has already been addressed and a report will be submitted within three weeks.

7. After hearing both the petitioner and the authority, the Commission made the following recommendations and action taken report may be submitted within 30 days:
- The Revenue authorities may immediately survey and demarcate the lands assigned to STs, as previously assured by the RDO.
 - The District Collector may ensure road access is provided to the residents of Saidonigadda Thanda.
 - The Government land encroached by the real estate company may be surveyed and reclaimed.
 - The NCST will schedule a visit to Saidonigadda Thanda shortly to understand the ground reality.
