Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shyam Sangodkar, Secretary, Gomantak Gond Maratha Samaj regarding use of abusive words with ST person in the name of community by the Secretary of Village Panchayat-Sancoale.

Shri Shyam Sangodkar, Secretary, Gomantak Gond Maratha Samaj, Goa vide his representation dated 25.10.2024 has alleged Mr. Orville Vales, Secretary of Village Panchayat Sancoale, has abused and threatend Mr. Rama Kankonkar, a Scheduled Tribe member and Tribal activist on 23.10.2024 during a protest against the Bhutani Project. It is alleged that Mr. Vales humiliated Mr. Kankonkar in public using casteist slurs and violated provisions of the SC/ST (Prevention of Atrocities)1989. The organization claims that Verna Police Station officials failed to take action under the Atrocities Act and has demanded immediate registration of FIR against Mr. Vales under relevant sections action against negligent public servants under Section 4 of the Act and ensuring safety of Mr. Kankonkar.

- 2. The Commission issued notice to the Collector & District Magistrate, South Goa and Superintendent of Police, South Goa on 19.03.2025 seeking facts and comments within 30 days from receipt of the notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 24.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025.
- 3. The Collector & District Magistrate, South Goa District vide letter no. 18.7.2025 has furnished the facts and comments and stated that the matter has already been enquired by Goa Commission for SCs and STs. It has also been informed that the charge sheet has filed before the Special Judge, District and Sessions Court, Margao as Case No. LC/199/2025, which is pending for trial. In addition to that One Lack Rupees has been sanctioned out of which Rs. 75,000/- has already been issued.
- 4. In the sitting, the authorities were not present. But the representative of the petitioner alongwith victim were present. The petitioner and victim has reiterated his earlier submission and stated that the District Administration and Police official has not taken action against the accused person, so far. The compensation has also not received by the victim so far. It was also informed by the petitioner, a case has been filed against him by the accused.
- 5. It was observed that the District Administration, South Goa has not taken action against the accused person and also not present in the sitting before the NCST for discussion in the matter.
- 6. After discussion with petitioner and facts submitted by the District Collector & Magistrate, South Goa dated 18.7.2025, it was observed that the case is pending for trial before the Special Judge, District and Sessions Court, Margao as Case No. LC/199/2025. Hence, it would not be appropriate on part of NCST to proceed further. However, the District Administration of South Goa is advised to ensure for disbursement of compensation to victim, under intimation to NCST. The Police Department of South Goa is also advised to circulate an advisory to all Police Personnel about the ST grievances and the rights provided to the ST communities under Constitution of India. The report on facts of the case and the progress and action taken may be furnished to NCST.
