Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of General Secretary, All India ST Employees Association of Alluri Sitarama Raju (ASR) District Paderu regarding violation of LTR and cancellation of bogus ST certificates.

Shri J. Sambasivarao, General Secretary, All India ST Employees Association of Alluri Sitarama Raju District Paderu vide representation dated 26.09.2024 has represented against the LTR violations, prevalence of bogus ST certificates and illegal constructions by Non Tribals in the Scheduled areas in the ASR District.

- 2. The Commission issued notice to the Collector & District Magistrate, Sri Alluri Sitharamaraju District on 19.03.2025 seeking facts and comments within 30 days from receipt of the notice. The reply was not received, hence, NCST has decided to discuss the issue with the authority and the petitioner on 24.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025.
- 3. In the sitting, the Collector & District Magistrate, ASR District and petitioners were present. The petitioners have reiterated their earlier submission and requested for justice. Collector & District Magistrate, ASR District provided the letter no. 82/2025/E4 dated 18.7.2025 which contains the facts and comments on the issues raised by the petitioner. In regard to violation of LTR in the District ASR, the action will be taken after due enquiry. Regarding allotment of land in favor of the ST community, the matter will be examined in consultation with the Revenue Department to settle the case. The petitioner demanded that the ST certificates of the various persons of the District, who does not belongs to ST community requires to be cancelled immediately.
- 4. After discussion with Collector & District Magistrate, ASR District and petitioners, the following recommendations were made and action taken there on may be submitted to NCST at the earliest.
- The necessary action may be taken by District Administration of ASR to vacate the land which comes scheduled areas in the District of ASR, as raised by the petitioner and as assured by the District Collector in the sitting.
- A joint meeting with the Officials of Revenue Department of the State Government, the
 Departments concerned and Tribal associations in the District and Villagers may be made to identify the
 lands that are enncroached by Non Tribals and to protect the ST lands in accrodance with LTR
 provisions.
- The Collector and District Administration, ASR is advised to remind the State Level Scrutiny Committee (SLSC) for verification of SCs and STs certificate for disposal of the cases of the persons, whose ST certificates are decided as bogus by the District Administration, ASR.
