Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Banoth Cheena, S/o Vashram, R/o Gaghunadhapalem, Khammam District, Telangana State regarding land related atrocities committed on him.

Shri Banoth Cheena s/o Vashram, R/o Raghunadhapalem village/mandal, Khammam District, Telangana, has submitted a petition dated NIL regarding name change in Pattadar Passbook and alleged illegal occupation of his ancestral agricultural land (Survey No. 17/6, Khata No. 246) measuring 1.35 guntas, which he claims to have inherited from his grandfather Banoth Thavurya s/o Pandya. He has alleged that several local influential persons, including ex-village presidents and corporators, conspired to manipulate land records with the help of the MRO and local police, and fabricated documents with different survey numbers. On 25/01/2024, the Raghunadhapalem Police allegedly forcibly detained him and his family, destroyed crops and built a fence around his land. He claims they abused him with casteist slurs, threatened to book him under the PD Act and coerced him to sign documents at the MRO and RDO offices in the presence of the Khammam Collector, which he refused. He seeks legal action against those responsible and restoration of his ancestral land.

- 2. The Commission issued notice to the Collector and District Magistrate, Khammam and Superintendent of Police, Khammam on 16.05.2025 seeking facts and comments within 30 days from receipt of the Notice. The reply was not received from authority, hence, NCST has decided to discuss the issue with the authority and the petitioner on 24.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025. Meanwhile, the letter no. DCO/C1/0004/2025 dated 4.7.2025 of the Collector & District Magistrate, Khammam received in NCST. In the letter, the facts and comments on the issue raised by the petitioner was mentioned, it has been informed that the petitioner has filed a case before the Hon'ble High Court in WP no. 12492/2023 and 20241/2023. The matter is pending with the Hon'ble Court.
- 3. In the sitting, the authorities were not present. But the petitioner was present.
- 4. After discussion with the petitioner and facts submitted by the District Collector & Magistrate, Khammam dated 4.7.2025, it was observed that the case is pending before the Hon'ble High Court, hence, it would not be appropriate on part of NCST to proceed further.
