Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Govinda Nayak and others from Raichur, Karnataka regarding possession of ancestral land.

NCST/DEV-5142/KA/1/2025-RU-III

Shri Govinda Nayak and others from Raichur, Karnataka, have submitted a petition stating that they and their family have been cultivating their ancestral land in Sy No. 55/1 and 55/2, measuring 6 acres 22 guntas each, for over 40 years, but their names have not been entered in the revenue records. Instead, names of persons not belonging to Scheduled Tribes have been recorded through alleged forged documents. Despite appeals made in 1991, 2013, and to the Karnataka SC/ST Commission in 2019, no relief was provided. They request the Commission's intervention to protect their constitutional rights and direct the inclusion of their names in the land records, specifically in column 9 and column 12 of the RTC Pahani.

2. The Commission issued notice to the Collector and District Magistrate, Raichur on 16.06.2025 for seeking facts and comments within 30 days from receipt of the Notice. The reply was not received from the authority, hence, NCST decided to discuss the issue with the authority and the petitioner on 23.07.2025. Accordingly, a Sitting Notice was sent on 16.07.2025.

3. The Deputy Commissioner, Raichur vide letter no. DCR/PA-Section/2025 dated 17.7.2025 has sought exemption and deputed Asst. Commissioner & Sub Divisional Magistrate, Raichur to attend the sitting. The Dy. Commissioner has furnished the facts and comments alongwith supporting documents in the matter.

4. In the sitting, the Asst. Commissioner & Sub Divisional Magistrate, Raichur and petitioner were present. The petitioner has reiterated his earlier submission and requested for justice. The Asst. Commissioner, Raichur has reiterated his earlier submission submitted by the Dy. Commissioner, Raichur vide letter dated 17.7.2025. It has also been informed that the petitioner has filed a case before the Prl. Sr. Civil Judge and CJM, Raichur in 2013, which was dismissed by the Court on 6.3.2020. The petitioner informed that the land was sold by his elder brothers but blood related persons of the purchaser are also not in possession of this land. The said land is being cultivated since inception by him. The authority informed that the purchasers heirs filed a case for partition of the said land. The authority also assured that he will call both parties for ascertaining the claims of each of them and for settling it amicably.

5. After discussion with the concerned authority and petitioner, the following recommendations were made and action taken there on may be submitted to NCST within 30 days from receipt of the minutes.


- As assured by the authority, the claims of petitioner and the opponent may be ascertained and also verified by conducting a Gram sabha and the issue may be resolved in accordance with the procedure of law.
